From the Chair.... a monthly report



Updates:

Finally as I write this driving instructors are allowed back to work in all nations and the great "catch up" has begun both with training and testing. It's quite a balancing act because it is so busy but a huge relief to be back at work. It's a large part of my day answering the phone to new requests for help from customers and speaking to some of the larger driving schools they are inundated with work and calls too. That's all good news and very positive for our livelihoods and so we can manage our own finances now we are earning again. However it is essential that we still need to be careful to maintain Covid-19 precautions because The World Health Organisation say that new variants will be around for some time so we will need to manage our training environment carefully. Personally even before the pandemic I would wipe down the steering wheel and controls now and again because I realised the importance even then but it was nowhere near as methodical and frequent as it is now. We will need to continue with that for some time yet and to consider still using face masks in the car until we know it's safe not to, even though it may not be compulsory everywhere except on tests. Complacency isn't going to keep us safe so we need to keep going with, washing hands, wearing masks, sanitising the car between customers and keeping to social distancing rules whenever possible. The better weather, apart from the showers, will help as we can comfortably have more ventilation in the car and get out of the vehicle to give feedback and talk to customers. More ADIs and examiners will be completing their vaccinations and all of this will help the return to a more normal life.

On a different note, do read the item in this newsletter on a project from Bikeability which NJC has been supporting, they are looking for 4,000 ADI volunteers so read about it and consider if you want to join in.

Your recent frustrations and feedback to us:

We have been liaising and dealing with a lot of queries from members since the return to work and firstly thank you for your comments such as the ones below because I do feel very proud of the team we have created at NJC and how hard they work on your behalf:

Thanks to all, you are a wonderful team. Helen James

We collated your feedback and have sent it to DVSA to highlight the issues around the country. They have sent it to senior colleagues and it will also be discussed at the next NASP/DVSA meeting taking place this month. We will need solutions to the issues in order to improve the catching up process for testing.

- ADIs have students who are test ready but who can't get a test date.
- ADIs are inundated with calls from people who have a test booked but don't have an
 instructor.
- Some callers have got a test booked, but have had no lessons and done no driving at all.
- Students are refusing to take instructors' advice on postponing tests and taking tests in their own cars.
- Companies who appear to have managed to get test slots, sold them to candidates and then attempt to find instructors.

The difficulties that this situation creates are:

- Frustration for ADIs and students unable to get test dates when they know there are people who have tests that aren't ready.
- Parents who will take their children for test in the hope that they will pass.
- Waiting lists getting longer because people aren't test ready.
- Examiners exposed to high risk situations with people not properly prepared.
- Test slots that will go unused because people who can't get an ADI may just not turn up as there is no penalty for loss of fee.
- Some candidates possibly managing to pass but not adequately prepared for real life driving.
- When a test is terminated early, they return to the test centre. If they have managed to get that far with no, or few, driver errors, they feel that they had a good drive and only 'slipped up' so they don't need more lessons before taking another test.

At NJC we have discussed the possibilities of whether the current situation of not losing the test fee is contributing to this problem. Would its reinstatement at least mean that people would cancel early so that the tests can go back in the system? Should a short notice cancellation have to be accompanied by a positive test result? These are some solutions we have suggested. We also want to see more test slots released this year and next and a rise in the number of tests each day. We want to resume normal testing in June after the Government hopefully announce on June 21st the final phase of their plan where social distancing measures are removed.

June 5th Association Meeting:

Details of our next meeting by zoom are in this newsletter but as mentioned at the last meeting we will be announcing in more detail the changes we are making to the structure of the NJC membership. The ADINJC was formed in 1973 and has consistently made changes it felt was necessary to help maintain the efficient running of the organisation. It's vital we do that so we can be here for many years to come, change is necessary as we grow so rapidly and we have invested money into a new website system that will allow us to work more effectively for all of you. We also have 2 speakers at the meeting: Charles Moffat presenting on dealing with customer complaints and a presentation by John Rogers, Chair at the Disability Driving Instructors Association, with updates on accommodating candidates with Special Needs.

The II & ADINJC Conference & Expo 2021:

We are truly excited as the prospect of the expo being able to take place becomes possible and so we are busy with more planning. It will most likely be the first time we will be able to meet you face to face and I'm sure there will be a real buzz around the whole event. So save the date on Sunday October 10th as we now have over 35 exhibitors booked, training sessions and speakers planned and a full day where you can attend for free. It's an opportunity to see what's new on the market to help your business flourish and to meet up with colleagues and industry experts. Visitors can also attend a wide range of seminars which will run in dedicated rooms throughout the day. Key topics include business growth, coaching, lesson planning, marketing, standards checks, training and teaching aids. We want to ensure people have fun that day and meet up with colleagues and friends. So, if you are new to the industry, perhaps considering becoming a driving instructor, are an independent instructor or even part of a franchise save the date and sign up to attend. 

Public Liability Driving Tuition

Why is Public Liability cover so important?

Because we all make mistakes in life, including in our business operations as a driving instructor. Quite simply, if a member of the public (or any other third party) is injured or suffers damage to their property, arising out of the conduct of your business as a driving instructor, you could be held responsible.

The ADINJC Public Liability insurance, is designed to provide protection from claims against you by third parties who may have suffered personal injury or damage to their property, during contact with your driving school. Most motor policies provide you with a compulsory £20 Million Public Liability cover for accidents and injuries that occur as a consequence of having an accident. The ADINJC believes it's important to ensure you also have sufficient cover away from the vehicle, and have therefore arranged for its paid up members to benefit from £10 Million Public Liability cover away from the vehicle. The policy also has a low policy excess of just £500 for each and every claim. The ADINJC policy provides £10 Million cover for each and every claim during the life of the policy.

A range of claims can arise. These can extend from accidents at your own business premises, to incidents that occur whilst providing advice or tuition whilst working away from your vehicle.

Increasingly, it is a requirement of many customers, principals, and clients (particularly local authorities and government agencies), that you be asked to present proof of Public Liability insurance before they will work with you, or allow you to work on their property or premises.

Compensation arising from Public Liability claims can be substantial, and may include loss of earnings, future loss of earnings and damages awarded to the claimant. In addition, considerable legal costs in defending the claim can be incurred, and the claimants' legal costs may also be awarded against you if you are found to be at fault. All would be covered under a comprehensive Public Liability policy

Claims for trips, slips and falls are the most common, but there are other events that can lead to a claim against you. The following are examples of potential claims that can give rise to public liability claims against your driving school:

- you open your door for a pupil who you inadvertently trip over, causing an injury;
- you spill a hot drink in a classroom and a pupil slips over on this, causing an injury;
- a pupil falls over some cones you have positioned to practice parking, causing an injury;
- · you knock over a valuable antique whilst waiting for a pupil at their home;

New Safe Driving For Life website

You should have received an update from DVSA advising you of the new Safe Driving for Life website that has been launched. https://www.safedrivingforlife.info

It's a collaboration between DVSA, The Stationery Office (TSO) and Sponge Learning. NASP would like to make you aware that, although we have helped to find some volunteer ADIs and their pupils to use the site and give feedback as requested by DVSA we were not aware of the content of the site when it was launched. NASP were expecting to be shown the content before it was released to the public as agreed with DVSA, however DVSA decided not to consult before publication, so we can assure you, what you see has not been influenced in any way by NASP, however DVSA have now agreed to NASP contributing to updating the content before the full launch of the website to the general public in the near future.

All systems go for driving lessons and tests

An update from Loveday Ryder, DVSA CEO to NASP association members:

It has been another tough lockdown, but some of us are starting to feel like there's a light at the end of the tunnel. Whether it's because Spring is in the air, you've had your vaccine, or you feel that things are starting to go back to normal. We have been busy over the last couple of weeks preparing for the safe restart of driving tests in England and Wales and know you will have been equally busy preparing to return to your important role of helping to keep our roads safe by offering essential professional instruction to your pupils. It hought i'd take this opportunity to undate you on even thing we did



Driving tests in England and Wales have now restarted

Driving tests restarted in England and Wales on Thursday 22 April. This is a huge milestone for us as it means all our driver and rider services, including vocational testing, are now back up and running in England and Wales. We were also able to confirm that lessons could restart on 26 April and tests on 6 May in Scotland.

Helping your pupil pass their driving test first time

As part of the restart, we published and promoted the *top 10 reasons for failing the driving test*, giving tips to you and candidates on how to avoid these faults. We're asking you to encourage your pupils to rearrange their test for a later date if they regularly make these mistakes during their lessons or private practice. We're also reminding learners to practise driving on a variety of roads and in different conditions, so they're better prepared for their test and driving on their own for the first time. Helping learners to be fully prepared will give them a better chance of passing, meaning they could potentially avoid a long delay to get another test and adding to our backlog. This has been widely picked up by national and regional media and well supported by driving



Helping your pupils who fail their test

We know failing a driving test is extremely disappointing, and candidates feel frustrated if they fail and have to wait longer for another test. To help them, we've *updated the guidance* which explains their driving test result.

You and candidates can use this to better understand the results of their test and consider what they need to do to be better prepared for their next test. There are useful guides on *GOV.UK* to help you do this. The guidance has been viewed over 4,450 times since we published it on Wednesday 21 April, with more than 86% saying that it was useful.

Making it clearer that driving test results cannot be changed

We have also taken the opportunity to publish *new appeals guidance on GOV.UK* to explain the legal grounds to make an appeal, how to appeal to a court, and what happens at the court hearing. This guidance also makes it clear that driving test results cannot be changed and the reasons an appeal will not be successful, such as:

- if your pupil disagrees with their test results or the driving examiner's judgement
- if your pupil felt unwell during their test
- if the car broke down during your pupil's test

What's next

The hard work now begins to reduce the backlog. There are currently over 400,000 candidates with a test booked and the national average waiting time for a driving test is 15 weeks. We'll do all we can to reduce the backlog safely and as quickly as possible to help the driver training industry recover. We plan to do this by testing as many people as we can, as soon as we can. The safety of you, your pupils and our examiners continues to be our top priority. Given the severity of the pandemic at the start of the year, we have restarted at 6 tests per examiner per day in England, Wales and will soon be doing the same in Scotland. This is a positive step towards our services returning to normal. We will only increase the number of tests when safe to do so and will then consider plans to start allowing you to accompany your pupils during their test again. We'll update you again on this as soon as we are able. You'll know that we've run a large national recruitment campaign for driving examiners. I know some of you may be asking why didn't we do this earlier so that more examiners were available sooner? As you'll appreciate, like driving lessons, the drive assessment or in-car training could not have taken place safely until April 2021. We've now completed the interview stage of the recruitment process, with over 450 interviews taking place. Drive assessments have started for successful applicants in England and Wales and will start shortly in Scotland. We'll keep you updated on their progress as the successful new recruits will start to join DVSA from this summer.

This is only one of the actions we are taking to reduce the backlog. We've already shared our outline plans with NASP to get their feedback and views. We'll share our full recovery plan with you all as soon as we can.

New study suggests drop in car usage...

...will continue despite lockdown easing and end of lockdown signals a rise in vulnerable road users

Thanks to Rhys Thomas at www.wmgagency.co.uk who sent me the following piece which shows that a drop in car usage will continue, and we are set to see almost 1 million less cars on the road compared to pre-pandemic levels. Over 2,000 people were surveyed as part of the study from National Accident Helpline, https://www.national-accident-helpline.co.uk which questioned British people on their intended main mode of transport once lockdown restrictions have lifted.

Key findings include:

- Increase in Britons relying on vulnerable transport methods such as walking and cycling, yet the
 vast majority seem unaware of the increased risk of Road Traffic Accidents the switch will bring.
- 60% of new cyclists are not concerned about a heightened risk of an RTA by switching to two wheels.
- 87% of new walkers also don't feel at a heightened risk of an RTA by switching their transport method.



Coronavirus restrictions are easing across the UK but the following guidance remains in place in England:

- Only socialise indoors with people you live with or who are in your support bubble
- Up to 6 people or 2 households can meet outside
- Work from home if you can and minimise travel
- If you have symptoms get a test and stay at home
- Step 3 not before 17 May (NB. The Indian C-19 variant of concern may well delay Step 4 which
 was due to take place on and not before 21 June please see below for more information.)

BE CAREFUL: A new COVID-19 variant is spreading in some parts of England.

The areas in which the new COVID-19 variant is spreading fastest are:

Given the increased risk of transmitting COVID-19, you should take particular caution when meeting anyone outside your household or support bubble. This will keep yourself and others safe. In particular, wherever possible, you should try to:

- Meet outside rather than inside where possible
- Try to keep 2 metres apart from people that you don't live with (unless you have formed a support bubble with them), this includes friends and family you don't live with
- Get tested twice a week for free and isolate if you are positive
- Continue to work from home if you can
- Get vaccinated https://www.nhs.uk/conditions/coronavirus-covid-19/coronavirus-vaccination/ coronavirus-vaccine/ when you are offered it, and encourage others to do so as well

By making safer choices and following public health advice, you can all help lower the spread of COVID-19 in the community.

Do your part to keep yourself and others healthy:

- book a test and self-isolate for 10 days if you have COVID-19 symptoms
- self-isolate if you have been identified as a close contact
- wash your hands
- wear a face-covering
- · keep your distance from others
- limit your contacts
- avoid large gatherings and busy places
- spend time outdoors rather than indoors
- don't travel to or from places with higher COVID-19 infection rates

How we plan to reduce the backlog for theory tests in England and Wales

New DVSA chief executive, Loveday Ryder, wrote to you on 25 March to set out our commitment to safely reduce the backlog of tests.

Theory tests restarted in England and Wales on 12 April -

Extending theory test centre opening hours

From Monday 10 May to Wednesday 30 June, we'll extend the opening hours at most theory test centres in England and Wales, where conditions allow. Typically, centres will be open earlier and close later in the evenings. For example, some centres will be open from 8am to 8pm, and some might be open on Saturdays and Sundays where they were previously closed. This will create 300,000 extra theory test appointments.

Opening 10 temporary larger theory test centres in England

On Monday 12 April, we started to open 10 temporary larger theory test centres.

These 10 temporary centres will create a minimum of 120,000 extra appointments each month. The centres will be in:

- Cambridge
- Huddersfield
- Leeds (there will be 2 temporary centres)
- London (Docklands) (there will be 2 temporary centres)
- London (Holborn)
- Manchester (Salford) (there will be 2 temporary centres)
- Wolverhampton

The full addresses for these centres have been added to the find a theory test centre service on *GOV.UK*

Taking a test at one of these temporary centres

These temporary larger theory test centres will work slightly differently to normal theory test centres.

- Some sites will have up-to 25 candidates testing at any one time. Robust covid-secure measures have been put in place to ensure the safety of candidates and staff, including: social distancing at least 1 metre apart from other people
- protective transparent screens at reception desks
- providing hand sanitiser to use on arrival, during the tests and when candidates leave the test centre
- cleaning workstations (including computers and headphones) before every test
- staff will wear a face covering (unless there's a medical reason that it's not recommended for

them) and gloves. Candidates will have to wear a face covering too unless they have notified us in advance that they cannot

• candidates must come into the test centre alone to help with social distancing

A full list of the safety measures in place at all theory test centres is available at Coronavirus (COVID-19): driving theory tests - GOV.UK

Your pupils will also notice

- mobile phones must be turned off before entering the test centre
- there are no lockers for personal belongings they will be given a rigid plastic box to put their belongings in and will need to keep this under their desk while they take the test. These boxes will be cleaned by us after use.
- invigilators will be walking around the testing room, monitoring people taking the test, observing social distancing guidelines at all times

These details will also be included in the theory test booking confirmation email.

Non-standard accommodations

We will prioritise candidates requiring special or additional support through dedicated appointments. At all locations, weekly appointments will be reserved to ensure that we have sufficient capacity to help reduce the wait time for these candidates.

What we will do next

We have added new appointments for the extending opening hours and the temporary test centres to the booking service. We'll contact everyone with a theory test booked in:

- England to tell them about the extended opening hours and contact candidates with tests booked at a centre close to the temporary test centres
- Wales to tell them about extended opening hours

They will then have the choice to change their theory test appointment to one of the new available appointments.

Preparing for a theory test

The current national average pass rate for a car theory test is under 50%, so it's important that your pupil is prepared for their theory test. They can use free practice theory tests on the Safe Driving for Life website to prepare and refresh their theory test knowledge ahead of their test: https://www.safedrivingforlife.info/free-tests

Update: Emergency theory test and driving test service for critical workers

We have now restarted theory tests and practical tests in England and Wales so we want to update you on our plans for emergency theory test and driving test services for critical workers.

Emergency theory tests for critical workers

We will no longer be offering a separate emergency theory test service for critical workers as customers can now book them as normal, and we have added extra capacity by:

increasing our opening hours to include evenings and weekends



opening 10 temporary larger theory test centres in England

Emergency practical tests for critical workers

Due to the backlog and high demand for practical driving tests, we will continue to offer a priority service for critical workers in England or Wales that work for one of the following:

- the NHS, in health or social care
- the emergency services
- a local council

To qualify the individual must also:

- · need to drive as part of their job
- respond to 'threats to life' as part of their job

We are continuing to work with Scottish Government about critical worker testing in Scotland and will update you in due course.

What this means to you and your pupils

If any of your pupils qualify for the service they'll need to talk to their employer who will need to apply for them. They can find out more by visiting the emergency driving test for critical worker pages on *GOV.UK*

New theory test booking service to go live from 8 July

We wrote to you earlier this year to let you know we are making changes to the theory test service by bringing more parts of it in-house. This includes the theory test booking service.

Launching the new booking service

The new theory test booking service, for England, Scotland and Wales, will be launched on Thursday 8 July 2021 when bookings will be taken online and via the DVSA customer service centre. This service is moving from Pearson VUE to DVSA.

The new online booking system will accept test bookings to be taken from 4 September when the new theory test service begins. Any test bookings for dates before 4 September must be made on the current system. All theory tests including ADI part 1 and enhanced rider scheme training theory tests are still booked from the current GOV.UK pages. For tests to be taken from 4 September, other than slightly different looking screens you and your pupils will not notice a difference. We have worked with theory test candidates and the Government Digital Service to improve the booking service by making it easier to use.

Temporary change in the booking window for theory tests

Currently theory tests can be booked 4 months in advance. From 4 May the amount of time that tests can be booked in advance will be reduced by one day. By the time the new booking system opens on 8 July, tests will only be available 2 months in advance. DVSA has taken action to reduce the theory test backlog by extending opening hours in England and Wales and opening additional temporary theory test centres in England. This has created additional test capacity, so the number of tests available to book should not be affected, just how far in advance you can book them.

Theory test centre locations

The contract for running theory test centres from 4 September has been split into 3 regions. Some existing test centres will change location and we are working with the new suppliers to confirm where the new theory test centres will be. We will share the addresses with you as soon as we can.

Restarting driving lessons and tests in Scotland

The Scottish Government has announced that from 26 April, all of Scotland will be placed in local protection Level 3. This means driver, rider and vocational lessons and tests will restart in line with the indicative dates we previously shared with you. Driving lessons can resume on 26 April and driving tests 10 days later on 6 May to give your candidates time to have refresher practice ahead of their test.

Test ready

We'll email candidates with car practical tests booked from the 6 May to let them know their tests will go ahead. If you have booked a test for any of your pupils from this date, please can you reassure them that their tests will go ahead as planned.

Restarting lessons 10 days ahead of tests will give you the chance to provide your pupils with professional refresher training before they take their test. We know many of you wanted the opportunity to carry out lessons and training before we restart driving tests and we agree with this, so do the National Association of Strategic Partnerships (NASP).

Instructor tests

We will restart instructor testing, ADI part 2 and 3 tests and standards checks from 6 May. If your part 2 or 3 test or standards check is on hold, we will contact you to arrange a new time and date as soon as we are able to.

Face coverings on driving lessons

In Scotland, by law, you and your pupils must wear a face covering during driving lessons unless you have a good reason not to.

Your pupils need to let you know before their lesson if they cannot wear a face covering or you can be fined.

Face coverings on driving tests

Your pupils must bring and wear a face covering for their practical test, unless they have a good reason not to. If they refuse to wear a face covering they will not be able to take their test. If they do have a good reason, they need to tell us when they book their test.

Face coverings on theory tests

Your pupils must bring and wear a face covering for their theory test, unless they have a good reason not to. They need to say if they have a good reason not to wear a face covering when they book their test. If they already have a theory test booked and have a good reason not to wear a face covering they need to call Pearson VUE on 0300 200 1122.

Theory tests

Theory tests will restart in Scotland on 26 April 2021. We'll email all candidates with theory tests

booked from this date to confirm that their test will go ahead.

Fleet tests

Fleet training and testing will also restart on 26 April.

England and Wales

Car driving tests restarted on 22 April in England and Wales, 10 days after lessons restarted on 12

Update on Scottish Local Protection Levels

The Scottish Government announced on 14 May that Glasgow City and Moray would remain in Protection Level 3 for at least another week. You can read more about the measures on the Scottish Government website.

All DVSA services will continue as normal in areas in Protection Levels 0 – 3. We will keep them under review in line with Scottish Government guidance.

Driving and riding lessons in Level 3 areas

The Scottish Government has confirmed that driving and riding lessons can continue in Glasgow City and Moray. They are unaffected by any travel restrictions so you can continue to teach pupils in any area.

Theory and practical driving, riding and vocational tests in Level 3 areas

The Scottish Government has confirmed that theory and practical driving, riding and vocational tests can continue in Glasgow City and Moray. They are unaffected by any travel restrictions so candidates can travel to their local test centre to take a test.

Mobile emergency testing service

Because of the current COVID restrictions, we are not able to offer a mobile emergency worker test service in Scotland.

Driving tests restart: actions to take now and on test day

Here's a reminder of some of the most important actions to take to work safely and make sure your pupils are prepared for their driving test.

Actions to take now

1. Review the guidance about working safely during the COVID-19 pandemic

The driving instructors' National Associations Strategic Partnership (NASP) has produced guidance to help you work safely during the pandemic.

Read the NASP guidance (PDF, 87KB).

2. Order rapid lateral flow tests in England - and encourage your pupils to do the same

If you're in England, you can get twice weekly rapid lateral flow tests. They're free, and you can order them online, or collect them from a test site and some pharmacies. Your pupils in England can also get them.

Find out how to get rapid lateral flow tests.

Take a COVID-19 rapid lateral flow test before your driving test (England).

3. Make sure you give your pupil's email address if you book their test for them

If you use the service to **book and manage driving tests for your pupils**, you'll need to enter your pupil's email address when booking their test from Tuesday 27 April. Your pupil's test result will then be sent to that email address.

4. Check if the driving test centre waiting room will be open

Most waiting rooms are open, but some are closed because of COVID-19. Make sure you check if your driving test centre's waiting room will be open.

Check the list of driving test centre waiting rooms.

5. Find out about the top 10 reasons people fail the driving test

The driving test pass rate was 45.9% between April 2019 and March 2020. Many people who fail the test make at least one of the top 10 faults. Use our new guide with your pupils and their parents to help them understand if they're ready to take their test.

Find out about the top 10 reasons people fail the driving test.

6. Remind your pupils their test will end early if they make a serious or dangerous fault

If your pupil makes a serious or dangerous fault (which means they've failed) the driving examiner will direct them back to the driving test centre. This is to minimise the amount of time they need to spend in the vehicle.

Actions to take on the day of the test

1. Clean the inside of the car before the test and let fresh air in

You must clean the inside of your car before your test and make sure that you've left fresh air in. You must have at least one window open on each side throughout the test, so your pupil needs to

wear clothing suitable for the weather.

Find out more about the *rules for the car used for the driving test*.

2. Wear a face covering

Your pupil must bring and wear a face covering when they come for their test, unless they have a good reason not to and they told us this when they booked their test. We strongly encourage you to do the same.

Read more about face coverings and driving tests.

3. Do not get to the driving test centre too early

You should arrive for your pupil's driving test no more than 5 minutes before the appointment time.

4. Follow the rules for using the driving test centre waiting room if it's open

There are temporary rules for using driving test centre waiting rooms during the pandemic. Make sure you're familiar with the rules before you go.

Read the *rules for using waiting rooms*.

Actions to take after the test

1. Encourage your pupil to read the new guidance to understand their test result:

You and your pupils can use new guidance to better understand their test result, find out how to improve their skills, and help them better prepare for their next test if they fail.

Read the guide about understanding your car driving test result.

2. Check the appeal guidance if your pupil thinks the test did not meet the legal requirements. Your pupil can appeal their driving test if they think it did not meet the legal requirements. *Check the reasons you can appeal a driving test.*

Helping your pupils pass their driving test first time

Driving tests will restart in England and Wales from 22 April. Driving lessons can resume in Scotland on 26 April, with tests restarting on 6 May. We know this will be a busy time for you, and that some of your pupils will have tests coming up soon. We want your pupils who are prepared to drive safely on their own to do so as soon as possible. We are asking for your support to make every test count.

The top 10 reasons people fail the driving test

We've published the top 10 reasons for failing the driving test to help learners understand the common faults and knowledge and skills they need to work on to pass first time. This includes tips for learners to improve their driving to avoid these mistakes. We're also encouraging learners to practise driving on a variety of roads and in different conditions, so they are better prepared for their test. You can read more on *GOV.UK*

How you can help

Focusing refresher lessons for those with tests from 22 April onwards on these 10 areas could make the difference between a pass or a fail. We know many of you will be chatting with your pupils with tests booked in the coming weeks to check they feel confident enough to pass their test. If they don't feel ready, they can reschedule to a later date for free and get more time to



practise so they pass on their first attempt.

Rescheduling a test

Pupils who do not feel ready to pass first time can reschedule their test for free at www.gov.uk/change-driving-test

Pupils who are fully prepared for a test can also use this service to find an earlier test date. We add extra tests to our booking service regularly and recommend pupils check availability at all local test centres if their nearest centre is fully booked. Learners who have practised on a variety of roads should be able to take a test anywhere and pass first time.

Keep a record of your pupil's driving lessons

You can use our free form (sometimes called the 'driver's record') to track your pupils' progress as they learn to drive.

The records allow you to:

- easily check what your pupils need to know by grouping together key skills
- include new stages of learning so your pupils can reflect on their lessons

You can download it from GOV.UK

Your pupils can also record any extra practice they do using the free form at www.gov.uk/dvsa/record-private-driving-practice.

They can then talk to you about their experience in their next lesson.

Make it count

There is no way to change the outcome of a driving test and we want everyone to pass first time. We've published new guidance about what a candidate needs to do if they want to appeal the result of their driving test. You can find out more *here*.

Helping your pupils who fail

We know failing a driving test is extremely disappointing and your pupils will feel frustrated if they fail and have to wait longer for another test. To help pupils who fail their test, we will update the guidance which explains the driving test report on GOV.UK on 22 April. You can use this with your pupils to better understand the results of their test, and get the information you need to help them better prepare for their next test. Thank you, Driver and Vehicle Standards Agency.

How the site works

Free rapid lateral flow tests for you and your pupils in England, Wales and Scotland

To help keep you, your family, your pupils and our examiners safe, we'd encourage both you and your pupils to regularly take coronavirus (COVID-19) rapid lateral flow tests. This includes while you're teaching them to drive and within the 4 days before they take their driving test. Around 1 in 3 people with COVID-19 do not have symptoms. Rapid lateral flow tests help to find cases in people who may have no symptoms but are still infectious and can give the virus to others. If you live in England, Wales or Scotland you can get a coronavirus (COVID-19) rapid lateral flow test if you do not have symptoms. They're free and you get a result 30 minutes after taking the test. Getting tested regularly is the only way to know if you have the virus. If people test positive and self-isolate, it helps stop the virus spreading. You should take a rapid lateral flow test twice a week (every 3 or 4 days). This applies even if you've had the first dose or both doses of a COVID-19 vaccine. The COVID-19 vaccine has been shown to reduce the chance of you suffering from COVID-19 disease. You may still get COVID-19 despite having a vaccination, but this should be less severe. The NHS does not yet know how much it will reduce the risk of you passing on the virus. You're also more likely to be teaching pupils in the age groups where the data shows infection rates are some of the highest and where vaccination is still to be undertaken.

What this means for your pupils

Your pupils will not need to take a rapid lateral flow test to be able to take their driving test, but by doing one, they'll help to stop the spread of COVID-19.

For the rapid lateral flow test to be valid, your pupil will need to take the test in the 4 days before their driving test. If your pupil or anyone they live with tests positive from a rapid lateral flow test, everyone in the household must:

- 1. self-isolate
- get a polymerase chain reaction (PCR) test to confirm the result (a PCR test is a different type of COVID-19 test)

If a PCR test result is negative

If your pupil and everyone they live with gets a negative PCR test result back before their driving test, they can stop self-isolating and take their driving test. If a PCR test result is positive or they do not get a PCR test result in time your pupil must not go for their driving test if either:

- they or someone they live with has a positive PCR test result
- their rapid lateral flow test result is positive, and they do not get a PCR test result back before their driving test.

They will need to change their driving test appointment https://www.gov.uk/change-driving-test to a later date. They can then email us if they'd like us to try and find an earlier appointment. They should email customerservices@dvsa.gov.uk with the email subject 'Lateral flow rebooking' and include 2 of these 3 pieces of information:

- · their driving licence number
- · their theory test pass certificate number
- · their driving test reference number

We'll then try to find them an earlier test appointment.

We'll only do this if they changed their test appointment within 4 days of their test. This service cannot be used by anyone else to try to get an earlier appointment. We will refuse anyone who is not eligible who tries to use this service. We're contacting all driving test candidates to let them know how to get a rapid lateral flow test and encourage them to get them while they're learning to drive and before they take their driving test. If you have a booked a driving test for any of your pupils, you need to pass this information on to them.

It's a double from John Farlam!

GDPR-UK and the topic of registration with the ICO

Last week I received a question about GDPR. The question was along the lines of (My paraphrased version):

"Hi John,

I have registered with the Information Commissioner's Office (ICO) and paid my £40 fee, however, talking to other instructors it seems that I'm in a minority and that most have not registered with the ICO – in addition, those I have spoken with have not taken any specific steps to protect the data they hold about customers since GDPR was introduced... Am I a bit of a 'mug' for paying?

A. Gold Member"

A bit of a 'mug' for paying for a legal requirement?

Well that depends on whether you want to be a law-abiding citizen and what future risks you are prepared to take with your ADI licence. Despite the fact that the UK has left the EU, GDPR is still in existence post BREXIT, but it is now regulated by the UK Government and has been renamed UK-GDPR. The rules and regulations are virtually the same as the previous GDPR (the changes are simply procedural issues).

I think that the following quote from the Information Commissioner's website also answers the "Am I a bit of a mug?" question. 'Every organisation or sole trader who processes personal information needs to pay a data protection fee to the ICO, unless they are exempt.' (Source https://ico.org.uk/for-organisations/data-protection-fee/) As a driving instructor you collect and process personal information which might include customer names, addresses and phone numbers, date of birth, provisional licence number (even if only briefly for test booking services), test pass data and possibly more besides. You might also have a dash-cam and/or internal cam which automatically requires you (as a business) to register even if you kept everything else in your head! It would be pretty well impossible to operate as an instructor without doing some of the things that require registration. The person asking the question noted that a couple of instructors told him that they had never been contacted by the ICO and so knew nothing about GDPR. The reason that instructors have not been contacted is simply that there is no compulsory business registration for sole-traders in the UK (other than for personal tax liabilities). The ICO do contact companies who are registered at Companies House (Ltd., LLP, & PLC Companies).

BUT...

Whether or not the ICO contact you there is still a requirement to register. It is the trader's responsibility to take advice and manage their business legally. Imagine if you had been working for a few years and had never notified HMRC for example – but no one contacts you to tell you that you must register and submit a tax-return.

My guess is that many (perhaps a majority?) of driving instructors and other small businesses that process data don't register with the ICO – I also suspect that they don't comply with the rules that cover the handling of data but registration is a legal requirement with fines ranging from £400 to £4000 for non-compliance.

The risks?

Whether or not you consider that you should register with the ICO depends on your attitude to risk. Some instructors are happy to use the phone illegally in the car and break speed limits if they are 'careful about where they do it'. However, the risks of doing these things are massive and could result in removal from the ADI Register if caught – the equivalent of a £150,000 fine if they were debarred from teaching for 5 years (plus the hassle of re-qualification if they were permitted to do so). The risks associated with GDPR could be just as serious as speeding or illegal phone use but the chances of being caught are probably lower. The only time that you would be caught would be in the event of a data breach or complaint. I've already mentioned the fines, but a fine is the least thing that an ADI would need to worry about. In the event of data breach you could also face claims for extensive damages from customers whose data has been 'leaked'. But although the risk of being 'found out' is perhaps lower than the speeding or phone use mentioned above, it's my guess that if you were prosecuted for a GDPR offence there would be a real risk of losing your ADI licence – and never being allowed to instruct again under the 'fit and proper person' catch all.

So, should you register?

In my opinion if you consider yourself to be professional you should most definitely register. Are you likely to be caught and fined if you don't? Perhaps not but if you are caught the consequences could be huge - not least the possibility of losing your ability to earn a living.



I'm sorry, but the issue of smart motorways has to be the lead item in my column yet again. There was a piece in the Mail of May 4th with the headline 'It's official: Smart m-ways are deadlier than regular roads.' The paper went on to say that official figures have shown that death rates on smart motorways with the hard shoulder permanently removed are higher than those on conventional motorways. The revelation blows a hole in Transport Secretary Grant Shapps' claims that smart motorways are 'as safe as, or safer than' their conventional counterparts. It also undermines a claim in the previous week by Highways England's acting chief executive Nick Harris that they 'are the safest roads in the country'. Evidence submitted to the Commons transport committee, which is investigating smart motorways, shows that in 2018 'live lane fatality rates' were more than a third higher on 'All Lane Running' (ALR) roads. These smart motorways have their hard shoulders permanently scrapped and converted into an extra lane, meaning motorists can become marooned in traffic rushing past them. In 2019, the live lane fatality rate on ALR roads was eight per cent higher than on conventional motorways. The Department for Transport figures, which include collisions between moving and stationary vehicles, show death rates were lower on ALR roads – the most common form of smart motorway – in 2015, 2016 and 2017. But they overtook the rates on conventional motorways in 2018 and 2019. The figures show live lane fatalities have surged on ALR motorways over the last five years as more miles of them have been rolled out. Meanwhile, the rate on conventional motorways has fallen. The Mail's piece was a lengthy one and told of victims, one of whom was only eight-year-old, and I won't bore you by repeating it here. Instead, I will just quote the Mail's comment piece of the same date: "Time to scrap these deathtrap motorways". I wholeheartedly agree.

And there was a story in the Auto Express of April 7th which said that number plates that reference Covid-19 have been banned by the Driver and Vehicle Licensing Agency (DVLA). An investigation by the Telegraph found that the organisation has forbidden the creation and sale of registrations such as 'COV 1D', 'COV 11D' and 'COV 111D' amid concerns they could cause offence to those who have lost family or friends to the virus. Number plates referring to the NHS are still allowed, however, and prices of these have reportedly increased as drivers look to pay tribute to the UK's frontline health and care workers. The DVLA holds a bi-annual meeting to work out which plates should be banned – the "vast majority" are made available, it says, but those that "may cause offence, embarrassment or are in poor taste" are eliminated. Good idea. And, by the way, I still have M5 PSL if anyone is interested.

There was an interesting piece in the Mail of April 8th. It had the headline 'Best place to find a Chelsea tractor really is in Chelsea'. It went on to say that they are favoured by mums for the school run and have been labelled 'Chelsea tractors' by critics. Now a survey has found the name really does ring true because the highest concentration of sports utility vehicles (SUVs) is in upmarket Chelsea and neighbouring areas of London. Popular SUVs include the £23,000 Nissan Qashqai, the £32,000 Range Rover Evoque and the £40,000 BMW X3. Some weigh more than two tons and have four-wheel drive more suited to off-road conditions – far from those found in cities. Analysis, commissioned by think tank the New Weather Institute and climate charity Possible, found the top three districts for large SUVs in the UK are the London boroughs of Kensington and Chelsea, Hammersmith and Fulham, and Westminster. One in three new cars bought privately in these districts is a large SUV, according to sales in 2019 and 2020. Critics claim most are used for shopping trips and dropping children off at school – clogging up tight city streets with their big engines pouring out pollution. Study co-author Andrew Simms, of the institute, said the home of the Chelsea tractor 'really is Chelsea'. He added: 'One of advertising's biggest manipulations has persuaded urban families that it's perfectly normal to go shopping in a two-ton truck.

Robbie Gillett, of Possible, claimed car companies have promoted SUVs as a 'luxury status symbol for far too long'. Steve Gooding, of the RAC Foundation, urged drivers to choose 'the right vehicle for the right trip to cut the size of our carbon footprint'. Well, Mrs Adrian and I have the choice of a petrol Swift Sport, a hybrid eNero or a diesel Yeti 4x4. So I reckon we are doing our bit, don't you?

There was an alarming story in my local regional daily, the Western Morning News on April 12th. It told how two Devon and Cornwall Police officers have been dismissed without notice after filming themselves driving at 89mph in a seized car. Police Constables Shaun Pearce and Daniel Pike were found to have committed gross misconduct during the incident in January 2019. Devon and Cornwall Police said the officers were on duty in the "No Excuses" road safety team at the time. (You couldn't make it up, could you?). It was alleged that on January 16th, 2019, the officers had seized a vehicle as part of "The Fatal Five" campaign, which aims to tackle issues such as speeding. A force spokesman said: "Pc Pearce drove the vehicle, without the consent of its owner, for 3.1 miles, at one point reaching a speed of 89mph. Pc Pike was a passenger and filmed part of the driving, including the excessive speed. This footage was then shared with other officers via a WhatsApp group". Following a three-day public hearing, a misconduct panel concluded that the allegations were proven, the force said. The officers were found to have breached the expected standards of professional behaviour during the incident and they were dismissed without notice on March 25th. Good grief!

There was a piece in Classic Car Buyer on April 14th, that brought us up to date on what the paper calls the 'Pothole plague'. Maintaining local roads in England and Wales to their target condition is still way out of reach despite a 15% increase in budgets, according to the latest Annual Local Authority Road Maintenance survey produced by the Asphalt Industry Alliance. (I bet you have never heard of them). This year's Pothole Impact Tracker report shows that the total cost to British drivers from pothole damage over the last 12 months was slightly up, reaching £1.267bn compared to £1.249bn for the year to March 2020. While slightly fewer drivers have suffered damage than in the previous year, the average repair cost per driver is up by 11% to £127.20, resulting in the slight rise in the national bill. Nearly half (48%) of all drivers say that the condition of the road surfaces in their local area are worse than 12 months ago, with only 12% saying they are better. Well, there we all are then.

There was an interesting story in the Mail on Sunday of April 25th. It said that, as the new owner of a £220,000 Bentley, the Duke of York can expect no shortage of admiring glances. But one woman is distinctly unimpressed by his expensive new toy – French socialite Isabelle de Rouvre. The 75-year-old mother-of-four is suing the Duke and ex-wife Sarah Ferguson for £6.7million, which, she alleges, remains outstanding from when they bought her alpine chalet in Verbier in 2014. Last week, Andrew was driven from his father's funeral in the 200mph Flying Spur, which he has had resprayed in British racing green. While his extravagance has raised eyebrows in some quarters, Ms de Rouvre declared herself not in the least bit shocked. "You know, nothing surprises me about him. Nothing." She told the Mail on Sunday pointedly. She said she hopes her legal action to recoup her millions will be resolved "soon", adding: "The case is in the courts." Andrew, who stepped down from Royal duties over the continuing scandal of his friendship with paedophile Jeffrey Epstein, took delivery of the Bentley in September. It came in blue, but the colour was not to his liking, so he arranged for it to be resprayed. It also now has personalised number plates. How the other half lives, eh!

And Auto Express of April 14th had a piece which said that learners are facing long delays for practical driving tests, with a huge backlog having built up during lockdown ahead of tests resuming on April 22nd. The Driver and Vehicle Standards Agency (DVSA) says there are currently 420,000 practical tests booked in its system, with the national average waiting time for a driving test now up to 17 weeks from booking. This will vary by region, however, with some test centres experiencing higher demand than

others. In December 2020, before the start of England's third national lockdown, the DVSA had 1,461 driving examiners available for testing. These examiners work to strict test and administrative schedules, however, and can't adjudicate any more exams in a given day than they normally would. As such, the DVSA is sequestering 307 managerial and desk staff who are qualified to run driving tests to help deal with the backlog. A further 300 examiners are being recruited, and tests are being conducted on days when they normally wouldn't – the DVSA ran tests on Boxing Day last year, for example. In addition, the organisation is initiating plans to eliminate the cumulative backlog of theory tests by August 2021. I've said it before and I'll say it again – I'm so glad that I have retired!

And there was a story in the same issue of Auto Express which said that the number of learner drivers and riders crashing during their practical tests has been on the rise. DVSA data shows that 695 candidates crashed during their tests in the 2019/20 financial year, up from 637 in 2018/19, and 414 in 2015/16. The data, obtained via freedom of information requests by car retailer Group 1 Automotive, shows 3,114 candidates have crashed during tests in the last six years. Of these accidents, 2,869 involved car drivers, 52 were motorcyclists, 177 were for goods vehicle drivers, and 13 were people taking their driving tests in cars with trailers. There were only 137 incidents in 2020/21 due to Covid restrictions stopping tests. Regardless of the period, they're a tiny fraction of the 1.6million people who take a practical test in any given normal year. On average, just 0.035% of learners had a collision during their tests. Interesting stuff, do you not think?





In Scotland - the 16 week waiting times for theory tests has been addressed by DVSA as follows:

We are doing all we can to offer more tests at our centres in Scotland by increasing their opening hours and running tests on extra days where possible. However, DVSA has to deliver services within the guidance or legislation of the devolved nations. With the exception of Scotland all other nations have moved to a one metre Covid safe model allowing us to offer our customers in England and Wales more tests.

We continue to work with the Scottish Government but as a result of the 2 metre physical distancing restrictions in Scotland we are unable to increase the number of desks used to take tests.'

We were asked about the recent DVSA comms that said the pupil's email address should be given if you are booking tests for your students, and made enquiries with DVSA:

'As the test is the candidates test and the end of test summary / driving test report relates to their performance, there is a requirement that the documentation should be provided to the candidate, who for the purposes of the test, is the customer. As well as their performance, the document includes other important information that is relevant to the candidate, including a 'Statement of Failure' for those who are unfortunately unsuccessful, data privacy information, pass plus information etc and a customer satisfaction survey. The candidate then has the option to share the summary or forward it on to their driving instructor, if they wish. This is even more relevant than ever with the updated and improved guidance to understanding your test result. Providing the report to the candidate was always the case with the paper version, which was handed to the candidate at the end of the test. Therefore providing the candidate email address is the preferred option, but it is not a 'must' as there will obviously be occasions when a candidate may not have an email address or may prefer the end of test summary to go to a different email address, including their driving instructor. Whichever email address is provided at the point of booking will not interfere with the booking process and is not verified until the candidate attends for test. During the meet and greet at the test centre, the candidate will be asked to confirm that they are satisfied for their end of test summary to go to the email address provided and have the option to change it if they wish, which still satisfies the requirement of providing a copy of their report. Allowing the candidate to change the email address during the meet and greet will cater for a change in their circumstances where the initial email is no longer applicable, if the email provided is a previous ADI, if there are mistakes (spelling) with the email provided etc.'

ADIs not wearing masks?

We've heard reports of ADIs not wearing masks in lessons. Please do follow the guidelines and wear masks, along with your learners. Good hygiene must still be followed, with cars being sanitised between lessons, and if you touch the controls during a lesson. Do also keep windows open for optimised circulation - nobody wants another lockdown!

Keep checking the booking system

You can book and change tests if you can find slots. New slots are being added when they become available so it is well worth checking the system.

Late test cancellations

A member group enquired about late test cancellations, so we thought it would be worth reminding you of the current situation. The policy of not losing the fee for a late cancellation remains in place currently. If your student no longer needs their test, or is unable to attend because they have Covid symptoms, then it is free to change the test. They can change their test here:

If they don't cancel it but don't attend for the test, they will be sent a refund rather than a new test date. If you have a candidate who is unsure whether to take their test, then obviously if you can persuade them to cancel early, this will release that slot for someone who is desperate to get their test done.
