

#### Helping ADIs and PDIs: A hardship fund:

As I've been mentioning help for ADIs I wanted to take this opportunity to remind you of the special fund that was set up in 2020 by 2 very dedicated ADIs in response to the Covid crisis. Its aim initially was to provide small grants to ADIs and PDIs who had been unable to work and were facing real hardship. #### Important changes to the Highway Code in 2022:

As I'm sure you are aware the Highway Code is a set of information, advice, guides and mandatory rules for road users in the United Kingdom. It contains information about road signs, road markings, vehicle markings and road safety. There are annexes on vehicle maintenance, licence requirements, documentation, penalties, and vehicle security.

It applies to all road users, including the most vulnerable: pedestrians, mobility scooter users, cyclists, horse riders, drivers and motorcyclists.

It was first published in 1931 and is regularly updated to reflect current practices.

The Highway Code has changed - with 33 updates to rules and two new laws being added. My understanding is that the date for change will be 29th January.

This move, which comes as part of the government's new £338 million fund to boost cycling and walking intends to help accommodate and maintain the increase in active travel during the pandemic. Transport Secretary Grant Shapps said: "Millions of us have found over the past year how cycling and walking are great ways to stay fit, ease congestion on the roads and do your bit for the environment. As we build back greener from the pandemic, we're determined to keep that trend going by making active travel easier and safer for everyone."

He added that the funding package will enable more people to make "sustainable travel choices" that make our "air cleaner and cities greener".

The important main facts to note are that there will be a "hierarchy of road users" to ensure the more high-risk modes of transport have the greatest responsibility to reduce the danger they pose to others.

This will ensure that people who can cause the most harm in a collision, such as those in vehicles, bear the "greatest responsibility to reduce the danger they may pose to others". So, a lorry driver will have a greater responsibility to those driving a car or motorcycle, and likewise people cycling would have a greater responsibility than pedestrians. The hierarchy will be, in order of priority:

pedestrians; cyclists; horse riders; motorcyclists; cars/taxis; vans/minibuses, then finally large passenger and heavy goods vehicles.

Pedestrians will have priority on pavements and at zebra crossings.

Currently, drivers are only required to give way when someone steps onto a crossing, while pedestrians are told they shouldn't start to cross until vehicles on the road have stopped. The new rules will strengthen right of way for pedestrians on pavements and when crossing, or waiting to cross the road. The updated Code will also give cyclists priority at junctions when travelling straight ahead.

A new rule makes clear that at a junction, drivers should give way to pedestrians crossing or waiting to cross a road into which, or out of which, they are turning

Cyclists will have priority at junctions when travelling straight ahead.

When a car is turning into a road or exiting a road, they should stop to let pedestrians cross.

Cyclists will also have greater responsibility to look out for people walking.

#### Also:

- Electric vehicle drivers are advised to park close to charge points and avoid cables creating trip hazards.
- Drivers should also open car doors using the "Dutch reach" method with the hand on the
  opposite side to the door they are opening. This makes drivers turn their heads to look over
  their shoulders and reduces the likelihood of hitting a passing cyclist with the door.
- Cyclists should give room when passing pedestrians on shared cycle paths.
- There is also guidance on safe passing distances and speed.
- The new Code makes it clear that 20mph speed limits must not be exceeded by drivers.
- Stricter rules on mobile phone usage when driving e.g.
  - It will become an offence to take photos and videos
  - Select a song on your playlist
  - Play games on your phone, even if you are stopped at a red light
  - If you have your phone on a hands-free device then you will still be allowed to use it for directions.

The aim of the changes is also to improve guidance for drivers using motorways, including what to do during a breakdown or incident. This follows concern over dozens of fatalities on smart motorways, where there is no hard shoulder or the hard shoulder can be converted to live traffic. These proposals should make cycling and walking safer, which is good news but we now need to communicate these changes to the public not just drivers and learners because many do not read the Highway Code for long periods after passing their test.

Ultimately everyone using the roads needs to understand the new rules, because confusion could lead to high risk and collisions. As ADIs and PDIs it is our duty to incorporate this learning into lessons as soon as we can so everyone starts to understand the changes.

The updated Highway Code will affect England, Scotland, and Wales, while Northern Ireland has its own version.

I have some concerns especially the priority at junctions when turning left and needing to give way to pedestrians waiting to cross the side road, and cyclists who are going ahead at the junction when turning left. The latter less so in my opinion because people shouldn't be overtaking them just before the junction.

But the pedestrians could be a problem, especially if turning off a 40mph road and they have to stop. The worry is that the car behind won't realise that they may have to stop as they turn and a rear end shunt could occur possibly. Education of the public will be vital and we will need to play a very important role in this.



## Revised membership structure for Groups

As you're already aware, our revised membership structure for groups started on January 1st 2022. Please ensure you and your groups don't get left behind.

Here's a summary about Group membership for you all here:

- The group pays £120
- Once you've paid your subscription you will get a unique link to give to your group members, they can use this link to sign up for premium membership
- The link automatically applies a discount code giving free premium membership for the first six months when they sign up before 30th June 2022
- Following the initial 6 months free period they will then pay £2 a month for premium membership (this is half the price they would pay as an individual)
- If they don't want to do that they can sign up as a lite member to get all our mailshots for free. However they would not be entitled to the full benefits of membership
- For each member that signs up to premium membership using your link your group will get a once only commission of £5, payable at the end of the year

# Latest .GOV - England



#### England has moved to Plan B in response to the risks of the Omicron variant

COVID-19 remains a serious health risk. You should stay cautious to help protect yourself and others *https://www.gov.uk/coronavirus* 

#### 11 January

If you get a positive rapid lateral flow test (LFT) result, *most people will not need to take a PCR test* to confirm the result. You must self-isolate immediately if you get a positive LFT result.

- Wear a face covering in most indoor public places and on public transport
- Get tested and self-isolate if required
- Work from home, if you can
- Get vaccinated
- Get your booster dose
- · Let fresh air in if you meet indoors. Meeting outdoors is safer

#### Find out how to stay safe and help prevent the spread

It is still possible to catch and spread COVID-19, even if you are fully vaccinated

Omicron the current COVID-19 variant of concern is circulating across the UK and with abilities to spread more easily from person to person, it is advisable especially in light of continued relaxed social distancing measures, to keep checking your local and national news channels for the latest information on this and other variants.

# Staying informed...

Because this latest Omicron variant is bringing with it such rapidly changing news, please do keep checking your local and national news channels for the most up to date insights to ensure you are always informed. In reality, this is as much as you, your students and your wider communities can realistically do whenever/wherever possible to help curtail the virus from rapidly spreading which we know this particular strain is effectively doing already.

#### Latest .GOV - Wales



All of Wales is at alert level 2. Read the current guidance.

#### 6 January

If you get a positive rapid lateral flow test result, most people will not need to take a PCR test to confirm the result. You must self-isolate immediately if you get a positive rapid lateral flow test result.

#### 31 December

People who have tested positive for COVID-19 must self-isolate for 7 full days. On days 6 and 7 they should take rapid lateral flow tests 24 hours apart. If the results are positive, they should continue to self-isolate until they get 2 negative tests, or after day 10, whichever is sooner. If they are negative they can stop self-isolating. *Find out more about self-isolation on GOV.WALES*.

#### 26 December

Wales is at *alert level 2*. A maximum of 6 people can meet in venues such as pubs, restaurants, cinemas and theatres ('rule of 6'), 30 people at indoor events and 50 people at outdoor events. 2 metre social distancing is required in public premises and offices. Nightclubs are closed. Find out more on *GOV.WALES*.

#### Help keep Wales safe:

- get both of your jabs and booster when invited
- limit your contacts
- do a lateral flow test before seeing others
- get tested and self-isolate if you have symptoms
- outdoors is safer than indoors
- keep your distance when you can
- wash your hands
- wear a face covering

If you are over 18, you must show the *NHS COVID pass* to enter theatres, cinemas and concert halls.

#### Latest .GOV - Scotland



#### **Living Safely This Winter**

#### 6 January

If you're a close contact of someone with COVID–19 and you're fully vaccinated along with your booster dose, you can take daily rapid lateral flow tests for 7 days instead of self isolating. If you test positive or develop symptoms during this time you should self-isolate for 10 days. If you test positive for COVID-19 you should self-isolate for 10 days. You can end self-isolation early if you do not have a high temperature and get 2 negative lateral flow test results on days 6 and 7, taken at least 24 hours apart. If you do not have symptoms and get a positive rapid lateral flow test result, you must self-isolate. You do not need to take a PCR test to confirm your result.

#### 27 December

Up to 3 households can meet with 1 metre physical distancing between groups at indoor and outdoor venues like bars, restaurants, theatres, cinemas and gyms. Table service is needed if alcohol is being served.

#### 26 December

Large events have 1 metre physical distancing and are limited to 100 people standing indoors, 200 people sitting indoors and 500 people outdoors.

Follow the rules and guidance on how to stay safe and help prevent the spread of COVID-19.

#### To help protect yourself and others:

- get the vaccine or the vaccine booster
- if you don't have symptoms take a *lateral flow tests* test each time before you visit someone in a hospital or care home or before mixing with other people
- think carefully about unnecessary contacts with other people, especially in crowded places
   it would be sensible to postpone work Christmas parties wear a face covering where required
- if you have symptoms self isolate and book a PCR test
- wash your hands regularly, and cover your nose and mouth if coughing or sneezing
- open windows when meeting indoors
- if you can, keep your distance from people not in your group
- work from home if possible
- use the apps: COVID status (vaccine passport), Protect Scotland and Check-in Scotland



#### 5 January

If you get a positive rapid lateral flow test result, you should isolate immediately. You no longer need to book a PCR test.

#### 31 December

People who test positive for COVID-19 should isolate for 10 days from their PCR test date or when symptoms started, whichever is sooner. People can end self-isolation early if they get two negative rapid lateral flow tests – one from day 6 and the second at least 24 hours later.

#### 27 December

You should reduce social contact as much as possible by meeting in groups of no more than 3 households. Up to 6 people can meet in pubs, bars and restaurants, or up to 10 people if they're all from the same household. Only table service is available. 2 metre social distancing is required in public premises and offices. *Find out more about changes in Northern Ireland*.

#### 26 December

Indoor standing events are not permitted. Nightclubs are closed.

#### **COVID-19 Certification Scheme**

It is now a legal requirement to provide proof of your COVID-19 status before entering a number of premises including licensed hospitality premises, cinemas and theatres. #### Car and trailer rules coming into force

We wrote to you on 23 November to let you know that the changes to B+E testing had been re-laid in parliament to restart the process for this change. The legislation has now been passed and the changes have been brought into force from 16 December.

What this means for car drivers towing a trailer

Drivers who passed their car driving test from 1 January 1997 will be allowed to tow trailers up to 3,500kg maximum authorised mass (MAM) without passing an additional car and trailer test. DVSA stopped doing car and trailer tests from 20 September. *Click here for more information* about the new rules for towing a trailer or caravan with a car.

#### Changes to driving licences

DVLA will update affected driving licence records to reflect the changes. The car and trailer category (B+E) will be added to the driving licence when a new photocard driving licence is issued.

#### Make sure you tow safely

Although the law on who can tow a trailer has changed, your responsibilities have not. So whatever you're towing, make it SAFE:

**S**ervice – has it been serviced recently?

**A**ir in tyres – check pressure, tread depth and condition.

**F**it the breakaway cable or safety chain and check electrical connections.

**E**xamine lights, mirrors, load and weight limit, and do the jockey wheel test.

All car drivers wishing to tow a trailer for leisure or business will be encouraged to undertake voluntary training through an accreditation scheme which we are developing with help from the trailer industry and training providers. The scheme is planned to be launched early 2022 and will focus on a core module for all drivers, with sector specific modules for different towing activities.

#### Book and manage driving tests - get available test notifications

We know that you are extremely busy keeping up with demand for driving lessons and tests. We wanted to remind you about our free, online service you can use to book and manage driving tests that allows you to book and manage tests and set up notifications for available appointments.

#### **Book tests**

You can:

- view all the available appointments without having to enter a pupil's details
- book multiple tests at the same time, without having to pay for each individually
- set up favourite test centres to make it quicker to search for appointments at the ones you use most

#### To book a test, you need your pupil's:

- name
- driving licence number

email address

The service will already know your business email address, so you do not need to add it. You'll only be asked for your pupil's theory test pass certificate number if the service cannot automatically find a valid one.

#### Manage bookings

For tests already booked, you can:

- change the booking
- cancel the booking
- swap bookings between pupils
- update your pupil's details

You can change an appointment up to 10 times. If you need to make more changes after that, you have to cancel the test and rebook it.

#### Set up notifications

You can set up notifications for tests so the service tells you if appointments become available at times you want - including at your favourite test centres. You have to check the service for notifications - they're not sent to you by email or text. There's no guarantee the appointment will still be available when you read the notification, as someone else may have already booked it.

#### Try the online service before calling us

We are seeing an increasing number of calls to our customer service centre to swap tests. Due to unprecedented numbers of calls, the waiting times are currently much higher than normal, so we would encourage you to manage your tests using the online service. This will allow you to manage your test much more quickly. If you are not able to sort your query out using the online service, you can still contact our customer service centre, but it may take longer than usual to answer your call.

#### Tackling third party test booking apps and websites

It is important that it is a fair and level playing field for people booking tests. When testing restarted earlier this year, we were made aware that third-party booking sites were making it harder for you and your pupils to book tests. We have invested in making it harder for bots to access our booking services. In addition to checking if the user accessing the system is human using CAPTCHA checks (for example, click on all the images of traffic lights), we've introduced Advanced Bot Protection (ABP) into our firewall, which gives greater scrutiny of traffic on our booking services. We're already seeing the really positive impact of this. We'll keep looking for ways to tackle the bots and making a real person using GOV.UK the safest and fairest way to book a driving test without having to pay any additional fees.

#### Loveday Ryder writes to ADIs

Dear colleague,

As the year draws to a close, I want to thank you for your resilience, patience and support over the last year.

In particular, I want to thank you for everything you've done to help get newly qualified drivers on the road. By doing this, you've enabled them to access employment, education, healthcare, and social activities. I know many of you also offer training to full licence holders to improve their safety and competency. We acknowledge that achieving all of this



their safety and competency. We acknowledge that achieving all of this in 'normal' operating



conditions is challenging enough, never mind during pandemic.

I know many of you will be concerned about the increase in coronavirus (COVID-19) cases following the emergence of the Omicron variant, and its potential impact on yourself, your families, your pupils and your business. We and the Department for Transport are closely monitoring the situation and will continue to do so. We'll update you if anything affects our services as soon as we are able.

I also want to update you on the work we're doing and have planned to help reduce driving test waiting times.

#### Helping stop the spread of COVID-19 to keep driving tests going

Our top priority is to keep you, learner drivers and our driving examiners safe. If driving examiners test positive for COVID-19, they have to self-isolate for 10 days.

Just one driving examiner who has to self-isolate will cause 60 or more driving tests to be cancelled, even when we find ways to cover some of the tests they would have delivered.

To protect our driving examiners, we:

- keep our workplaces COVID-secure
- are asking our examiners to take regular rapid lateral flow tests (these help to identify people who have COVID-19 but do not have any symptoms)

You and your pupils are required by law to wear a face covering when attending a driving test and your pupil during their driving test (unless they're exempt and tell us when they book their test).

We also strongly encourage driving test candidates to take rapid lateral flow tests before they take a driving test. It's a situation where people are at a higher risk of passing on COVID-19, and taking a test can help stop this, help protect you, and keep our services going for everyone.

You and your pupils are required by law to wear face coverings while on driving lessons and when taking a theory test to help protect everyone and help prevent the spread of COVID-19. The science is showing that Omicron is more transmissible than previous variants and we all have a role to play in helping prevent this. I'd also encourage you to get boosted now.

#### You can book your booster here!

#### Reducing driving test waiting times

You may have seen the recent media stories about the increase to driving test waiting times and you will already have experienced the impact this is having on you, your pupils and your business.

As well as all the measures we've already been doing to reduce driving waiting times, from 6 December local driving test managers have also been carrying out driving tests for 2 days a week. This is as well as the work they're doing to help new-entrant driving examiners get up to speed.

#### Driving examiner recruitment

We've just completed the fourth phase of our driving examiner recruitment campaign.

Since we were able to restart in-car training in the spring, we've had 126 new driving examiners qualify and start testing. We have a further 23 people going through their training and we have a further 60 people booked on courses which will start in the new year. We'll keep you updated over the next few months.

To help to speed up the training process, we have identified 28 qualified colleagues who we are planning to train in January so they can support us with training the new recruits.

We are aiming to have 20 or more extra trainers in place from February to support our permanent training team for 6 months.

To help us to train the new examiners they may be accompanied by another examiner we ask that you let your pupils know this could be a possibility on their test.

#### Making every test count

Given the high waiting times we want to do everything we can to make every test count.

#### Bad weather

Getting every test possible taking place is more vital than ever before. We completely understand that none of your pupils wants their test to be cancelled after they've prepared so hard for it.

But unfortunately, we're in that part of the year where we might have to cancel tests at short notice because of bad weather. We only do this if it is absolutely necessary, and we do it for your safety, and the safety of your pupil and our examiners.

If we need to cancel a test due to bad weather, we will automatically book the test for the next available date at the same driving tests centre and send the new details to the email used to book the test.

#### Learner drivers not turning up for their driving test

We're also experiencing more candidates not turning up for their driving test without telling us. This wastes an appointment that someone else could have used.

It's possible that this is happening because they're not ready and decide not to take the test.

40,533 learner drivers have not turned up for their driving test since they restarted in April 2021.

The numbers of tests where this has been happening has been steadily increasing. In November, more than 6,600 appointments were wasted because people did not

turn up on the day which could have been used by other people.

#### Reducing the number of unused test appointments

We are also planning to remind learner drivers about:

- the documents they need to bring to their driving test
- the rules for using their own car
- making sure the car is COVID-secure



We'll explore using social media, email and text messages to do this to reduce the number of avoidable cancellations to an absolute minimum.

We'll also remind learner drivers about the need to change or cancel their driving test appointment if it's no longer suitable.

We reintroduced the charge for short notice cancellations on 14 June 2021. This means people who cancel their test less than 3 full working days beforehand will have to pay again, unless they can give proof that they've tested positive for COVID-19. Some 36,000 candidates have cancelled within 3 days since testing was resumed in April.

If you could also have conversations with your pupils about the impact no-shows have on service that would greatly help us in our efforts to make every test count.

#### Driving test change consultation

We will be launching a government consultation on a range of proposed driving test changes, which we are planning to publish in the new year.

These measures will help make sure learners are properly prepared before taking their driving test and give us greater flexibility on when we can offer tests.

We'll be providing more detail on the proposed changes and how you can get involved in the consultation shortly.

#### Keeping you updated

I know the uncertainty at the moment is worrying. And I know you are concerned about how you can support your customers, your business and your family at this time.

We will do what we can to continue to monitor the situation and keep you updated.

But in the current situation, things can change quickly and sometimes we cannot respond as quickly as we would like. Given this, I'd ask you to be patient with us and we will update you as soon as we can.

We respect the patience and professionalism the industry has shown throughout this pandemic, even though it has been incredibly frustrating at times given the multiple challenges we have had to face.

I also urge you to keep up to date with the driving instructors' National Associations Strategic Partnership (NASP) website.

I wish you, your family and your friends a lovely Christmas and New Year and I hope you all remain safe and well.

#### New Welsh social distancing measures in public spaces

On 22 December, the Welsh Government announced social distancing measures in Wales would be introduced from 26 December to stop the spread of COVID-19.

These measures will be reviewed by the Welsh Government on 31 December. Click here to read more about the measures.

#### Driving and riding tests lessons

All practical driving and riding tests and lessons with a professional instructor will continue. Learner drivers can continue practicing driving, but should be mindful of limiting their social contact with people outside of their household.

#### Theory tests

Theory tests in Wales can continue to take place with 1m plus distancing accompanied by robust COVID-safe measures to protect customers and theory test centre colleagues.

Theory tests at Bala, Carmarthen, Cardigan and Dolgellau Mobile theory test centres will need to be cancelled in January if restrictions continue as DVSA is unable to social distance customers safely within the mobile test vehicle due to ventilation constraints.

If your or your pupil's test booking is affected, we will send you an email to explain the impact on your test and what you need to do to rearrange the test.

Candidates will need to maintain a 2m distance within the test centre before taking their test.

#### Other safety measures that will be in place include:

- protective transparent screens at reception desks
- barriers between each of the work stations which means all candidates are social distanced by 1m plus during their test
- providing hand sanitiser to use on arrival, during the tests and when candidates leave the test centre
- cleaning workstations (including computers and headphones) before every test
- colleagues will wear a face covering (unless there's a medical reason that it's not recommended for them) and gloves
- candidates will have to wear a face covering too, unless they have notified us in advance that they cannot
- candidates must come into the test centre alone to help with social distancing

#### Driving test centre waiting rooms

The new social distancing measures mean we are limiting the number of people who can use our driving test waiting rooms in Wales from 26 December until restrictions are lifted. The maximum number of people who can use the waiting room will be displayed inside and outside of the test centre waiting room. People using these rooms will need to keep a 2m distance from others and use the hand sanitiser as provided.

#### Other waiting room rules.

Examiners will meet candidates at their vehicle before their test. Some waiting rooms will need to close where social distancing is not possible or our examiners need to use these areas to allow them to socially distance whilst at work.

#### This includes:

- Brecon
- Carmarthen (when the driving test centre manager is testing)
- Monmouth



Candidates, driving instructors and accompanying drivers will still be able to access the toilet at these sites on request. If you are accompanying your pupils to test at any of these sites you can wait on site if you need to in the car park, as long as it is in a safe location.

We are sorry for any inconvenience that this might cause.

#### **Update:** Welsh social distancing measures

This closure will allow us to change the location of workstations for examiners at this centre to maximise physical distancing.

If you are accompanying your pupils to test at this centre you can wait on site if you need to in the car park, as long as it is in a safe location. Candidates, driving instructors and accompanying drivers will still be able to access the toilet at Glasgow Anniesland on request. More driving test waiting rooms in Scotland may close for this reason as more examiners return to work after the Christmas period and as we recruit more new examiners - we will keep you updated.

We are sorry for any inconvenience that this might cause.

#### Ashford driving test centre is closing

We are writing to let you know that the Ashford driving test centre at Fir Tree Place, Church Road, will be permanently closing after **Sunday 10 April 2022**.

#### Tests booked at this site

We have tried to keep the number of tests affected to a minimum. Any tests affected by this closure will be moved to another local test centre, and candidates will receive an email notification from DVSA confirming the new location of the test. You need to tell your pupil about the change if you booked the test for them and it is affected. This is also where affected examiners will be working from, following the closure.

#### Why this is happening

DVSA is committed to providing value for money to its fee-paying customers and offering the best, most efficient service possible. This centre is closing because the cost of running this test centre can be saved and the same service can be provided from the Chertsey or Isleworth driving test centres. There will be no tests cancelled as a result of the changes, and the number of tests available locally will stay the same. Learners will continue to receive the same good service from Chertsey or Isleworth. They can practise on any roads and should not need to learn to drive at a test centre location.

#### Alternative test centres

The next nearest driving test centre will now be the Chertsey test centre, 6 miles from the Ashford test centre:

Unit 4, The Forum, Hanworth Lane, Chertsey KT16 9JX View a map.

Other nearby sites include, Isleworth (8 miles away): The Wireless Factory, Fleming Way, Isleworth TW7 6DB *View a map*.

We will also be holding a meeting for local approved driving instructors, which will be advertised at all these driving test centres in due course. We are very sorry for any inconvenience this may cause and thank you for your understanding.





Happy New Year! There was an amusing piece in the Mail on Sunday of December 19th, which told how a drink-driver tried to fool police by swallowing hand sanitiser before a breath test – without realising that the anti-bacterial gel contained alcohol. Shop assistant Sophie Nutter (appropriate name), 29 was told by a judge she was lucky not to be spending Christmas behind bars after the test showed 52 micrograms of alcohol in 100ml of breath. The legal limit is 35 micrograms. She had been spotted swerving across the road in her Suzuki Swift with four flat tyres and a broken windscreen. Police found her slurping from a bottle of hand sanitiser. The mother from Beverley, East Yorkshire, admitted drink-driving and using a vehicle likely to cause danger of injury on April 7th when she appeared at Hull Crown Court. Recorder Alex Menary told the court that Nutter had tried to swallow sanitiser, which contains 60 per cent alcohol, in a failed attempt to reduce her breath test reading. She had breached a two-year suspended sentence for drug offences imposed in October last year. She was given a one-year community order and a 23-month driving ban and must pay £100 costs. As Pete Seeger once sang - when will they ever learn?

And there was a story in the Mail of December 17th which told how a successful businessman who turned to drink driving during lockdown, crashed his £65,000 Tesla car as he drove himself to an Alcoholics Anonymous meeting. Software designer Peter Scott, 52, had drunk vodka before the meeting and was found by police in August slumped in the driver's seat playing games on his phone. The married father of three from near Macclesfield in Cheshire had 131 micrograms of alcohol in 100 millilitres of breath. The legal limit is 35 micrograms. At Stockport magistrates' court, Scott admitted driving with excess alcohol. He was banned for three years and given a suspended 12-week jail term. You couldn't make it up, could you?

There was a piece in the Mirror of December 16th, which said that Katie Price was told she was 'extremely lucky' not to be jailed after her drink and drug-fuelled car crash. The shamed model, 43, flipped her BMW X5 on a country road after spending the night drinking and taking cocaine at her home. She got behind the wheel despite being banned from driving and having no insurance. The mother-of-five, who has been banned from driving five times already, admitted all charges the day after the crash and had faced a maximum jail sentence of six months. District Judge Amanda Kelly reluctantly handed her a 16-week term, suspended for a year, and banned her from the roads for a further two years. The judge, sitting at Crawley magistrates court in West Sussex, told Price: "You deserve to spend Christmas behind bars. You could have killed someone's partner, child, parent or friend. You appear to think you are above the law. You have one of the worst driving records I have seen. If you put a foot wrong in the weeks and months ahead you will certainly go to prison". Price hung her head and looked tearful as the judge slammed her actions over the crash at 6am on September 28th. The star told police she had decided to go out and see a friend because she was 'lonely'. But she lost control of the BMW, flipped it on its side and ploughed into a hedge on the B2135 in Partridge Green, West Sussex. The former Loose Woman panellist told police officers at the scene: "I drank alcohol. I took drugs, I shouldn't be driving. I admit it." Tests later showed Price had 66 micrograms of alcohol in 100ml of breath. The legal limit is 35mg. The following day, Crawley magistrates said her sentence would be deferred provided she had treatment at the Priory Centre, did not offend again and was banned from driving in the interim. And Judge Kelly told her: "The public may be appalled to know that I cannot send you to prison today. But the law says that when a person had complied with the terms of their release then you have a legitimate expectation you will not be sent to prison today. You are extremely lucky the magistrates on

the previous occasions chose to defer sentence". As well as her suspended sentence, Price was ordered to attend 20 rehabilitation sessions, carry out 100 hours of community service and pay a victim surcharge of £85. Sussex Police said they may appeal. Good grief!

And there was a story in the Mail of January 3rd with the headline 'E-scooter rider, 74, killed in crash with parked cars'. It told how a pensioner riding an e-scooter was killed after crashing into parked cars the day before his 75th birthday. Great-grandfather David Ackers collided with two vehicles on his side of the road and died at the scene from a suspected bleed on the brain. It is not known whether he was wearing a helmet when he apparently lost his balance and struck the cars at 1.40pm on New Year's Day in Tameside, Greater Manchester. Mr Ackers, who was said to have been riding an e-scooter belonging to a family member, was a father of two, grandfather of four and had three great-grandchildren. In a Facebook post, his granddaughter Rebecca Young paid tribute to the man she called 'Garg': "My garg, my grandad, my best friend, the most amazing, most generous, caring, selfless man in the world went out today and had a bad accident. You were our rock, I just can't even come to terms with what's happened, I just can't. It's not right. You should be here celebrating your birthday, laughing and joking like you do every day! You just can't be gone, what am I going to do without you? Thank you for being my garg, and my babies' garg, me and the boys love you forever and always. I will make sure they know how much of an amazing man you were. Til we meet again garg aka my trendy garg. Goodnight garg".(I am not ashamed to admit that, as I type this, I have a tear in my eye). E-scooters are not allowed on public roads unless they are rented from Government-backed trial schemes. E-scooter owners may only use them on private land – not cycle lanes, pavements, or public roads. Mr Ackers' death comes days after it emerged that e-scooters are being sold on Amazon as the 'ideal' and 'perfect' way to commute. E-scooters were involved in 460 accidents in the UK and there were 484 casualties, of whom one died and 128 were badly hurt. It is my personal view that they should be banned completely.

And there was a piece in the Mail on Sunday of December 12th which said that Government minister feels that owning a car is out-dated 20th Century thinking and will soon become a thing of the past for most people in Britain. Junior Transport Minister Trudy Harrison, 45, told a green travel conference that the country was "reaching a tipping point where shared mobility in the form of car clubs, scooters and bike shares will soon be a realistic option for many of us to get around". Speaking to a virtual audience at transport charity CoMoUK (no I haven't a clue either), Ms Harrison said the UK needed to move away from "20th Century thinking centred around private vehicle ownership and towards greater flexibility, with personal choice and low-carbon shared transport". She added: "Changing the way people consider ownership and dependency will take time, but many things seem farfetched until they aren't, and I believe the same is true for shared mobility". Cars are responsible for about 13 per cent of Britain's greenhouse gas emissions. The Government said it intends to reduce emissions to net zero by 2050 and has committed £5billion to 'greener' transport such as walking and cycling. One way of achieving this is by the banning of new petrol and diesel cars from 2030. E-scooters are also expected to be made legal on UK roads (oh no!) to promote a greener way of getting about. Currently, almost 80 per cent of households own a car, according to figures by data firm Statista. This equates to 63.5 million households owning at least one car, out of a total 80.7million. Please don't tell them that the Adrian household owns six cars!

Well, I have managed to get this far in the column without mentioning smart motorways, but I am afraid that I can avoid it no longer. A piece in Classic Car Buyer of November 10th said that MPs are recommending that the roll-out of these roads should be paused for five years due to insufficient data on their safety. Last March, the Department for Transport responded to widespread safety concerns with an 18-point action plan for the future of smart motorways. This included making all

new schemes into all-lane-running (ALR) roads, in which the hard shoulder is permanently used as an extra lane. However, a new Commons' Transport Select Committee report calls that decision "premature" and says that there is not enough safety and economic data to justify continuing with the plans. Describing the available data as "limited" and "volatile", the report cites The Office of Rail and Road's observation that only 29 miles of ALR motorways have five years of safety information available, and that much less is available for the remaining 112 miles introduced before 2020. The Committee also concludes that the scale of safety measures needed to mitigate the permanent removal of the hard shoulder has been underestimated by successive administrations, the Department for Transport and National Highways, with DfT's 18-point action plan also not fully addressing the issue. Ultimately, the report calls on the government to pause the roll-out of all-lane running Smart Motorways until five years' worth of suitable data is available and safety improvements have been delivered and independently evaluated. Could there be a glimmer of light at the end of the tunnel?

And there was a story in the Mail of January 3rd, which said a surge in illegal number plate cloning has been blamed on drivers trying to avoid paying penalties for older polluting cars. Reports of cars being wrongly linked to fines for driving in 'clean air' or 'low emissions' zones have shot up, suggesting more and more rogue motorists are fitting fake plates to cheat city centre enforcement cameras. Birmingham, London and Bath have led the way on green zones. Bristol's clean air zone will charge older cars £9 and HGVs, buses and coaches £100 from the summer. Cambridge, Oxford, Manchester, Bradford, Sheffield and Newcastle could be next. And as more city centres bring in such zones, the AA fears the rise in fake plates has only just begun. You have been warned!

#### And finally,





# **Public Liability Driving Tuition**

Why is Public Liability cover so important?

Because we all make mistakes in life, including in our business operations as a driving instructor. Quite simply, if a member of the public (or any other third party) is injured or suffers damage to their property, arising out of the conduct of your business as a driving instructor, you could be held responsible.

The ADINJC Public Liability insurance, is designed to provide protection from claims against you by third parties who may have suffered personal injury or damage to their property, during contact with your driving school. Most motor policies provide you with a compulsory £20 Million Public Liability cover for accidents and injuries that occur as a consequence of having an accident. The ADINJC believes it's important to ensure you also have sufficient cover away from the vehicle, and have therefore arranged for its paid up members to benefit from £10 Million Public Liability cover away from the vehicle. The policy also has a low policy excess of just £500 for each and every claim. The ADINJC policy provides £10 Million cover for each and every claim during the life of the policy.

A range of claims can arise. These can extend from accidents at your own business premises, to incidents that occur whilst providing advice or tuition whilst working away from your vehicle.

Increasingly, it is a requirement of many customers, principals, and clients (particularly local authorities and government agencies), that you be asked to present proof of Public Liability insurance before they will work with you, or allow you to work on their property or premises.

Compensation arising from Public Liability claims can be substantial, and may include loss of earnings, future loss of earnings and damages awarded to the claimant. In addition, considerable legal costs in defending the claim can be incurred, and the claimants' legal costs may also be awarded against you if you are found to be at fault. All would be covered under a comprehensive Public Liability policy

Claims for trips, slips and falls are the most common, but there are other events that can lead to a claim against you. The following are examples of potential claims that can give rise to public liability claims against your driving school:


- you open your door for a pupil who you inadvertently trip over, causing an injury;
- you spill a hot drink in a classroom and a pupil slips over on this, causing an injury;
- a pupil falls over some cones you have positioned to practice parking, causing an injury;
- · you knock over a valuable antique whilst waiting for a pupil at their home;


# **Highway Code Changes**

# **Avoid London?**

#### 'Easiest' Driving Test Centres in the Country - Revealed!


# Always on my mind


