- a. Coronavirus disease (COVID-19);
- b. Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);
- c. any mutation or variation of COVID-19 or SARS-CoV-2;
- d. any fear or threat (whether actual or perceived) of a), b) or c) above;
- e. action or omission of any kind to control, prevent, suppress, mitigate, eliminate or in any way relating to any actual or suspected outbreak of or infection or contamination by any of a), b) or c).

### PMR 016

#### General Exclusion
