From the Chair.... a monthly report

Coronavirus has taken away our freedom and security and there is no doubt that the start of 2021 is going to be tough because we are fearing for our own health and that of loved ones as well as considering how we can manage further financial losses. Please sign this petition and also encourage all your pupils, their parents and partners to sign. *Extend driving theory test certificates expiring in 2020/21 by 12 months - Petitions (parliament.uk)* Numbers on it are growing quite fast but please pass it on and raise awareness of it as we need to help those candidates who have been so penalised by no extension to their date, which is adding months to their ability to pass a practical test and get

on the road. This will also be raised again at DVSA and Government level. Secondly we will be doing all we can to continue to raise awareness of the ADIs and PDIs who have been excluded from any financial help so far and for those who are struggling and need more financial help. As driving instructors we rarely get mentioned when financial help is discussed at government level.



Below is a list of what we will be undertaking in January to help you, it is not in any particular order of importance.

- The monthly newsletter will continue to bring you all the facts and news. We have been covering all 4 nations in the newsletter and will continue to do so.
- We also send out a monthly road safety newsletter from Graham Feest our road safety adviser at NJC. If you haven't read it before then this is your chance to do so! It comes out in a newsflash each month.
- Our help desk is available and if Peter our treasurer can't help you then he will pass the request to one of the team who will help. If it is out of normal hours then leave a message and we will get back to help you. The number is 0800 8202 444
- You can email us from your local groups and associations or as an individual member and we
 will endeavour to get back to you on the same day. Currently we are receiving a high volume
 of email requests so please be patient if it takes us slightly longer. secretary@adinjc.org.uk or
 chairman@adinjc.org.uk We also have a contact page on our website.

- Our newsflashes will help to keep you updated with news and if necessary we will be sending them at all times of the day and later into the evenings if we are able to.
- We will be running our Monday evening webinars again to help you with queries and to offer support
- We want to help with any financial advice we can and we will endeavour to help with the momentum that started later last year for the Excluded self-employed who have fallen through the cracks up to this point by lobbying and writing to essential representatives that can help.
- Our Talk Line will continue to run. Set up initially for ADIs and PDIs who were feeling stressed
 and were suffering from mental anxiety for all sorts of emotional and financial reasons we will
 continue to run this valuable service. It's a listening ear and for anyone calling to know you are
 not alone and there is someone to talk to. Details are on the end of the newsflashes we send
 out and are on our website www.adinjc.org.uk
- The committee will be available to attend any local association zoom meetings you would like us to take part in. We have attended numerous ones to date.
- · Our next Association Meeting by Zoom will be on Saturday March 6th, details will be sent out.
- We will continue to work with our associates in NASP (National Associations Strategic Partnership) as Tier 1 stakeholders with the DVSA and hold regular combined meetings with DVSA.
- We will continue to write to Government Ministers, HSE, DVSA, FSB and encourage yourselves to do the same when we consider it will be helpful to do so.
- We will continue to liaise with all 4 nations. We have recently had contact at a meeting with representatives from The Welsh Government, and we are starting to hold meetings with NIAIC (Northern Ireland Approved Instructors Council) who are the only stakeholder instructor group in NI who meet regularly with DVA. Our Ambassador for Scotland, Stewart Lochrie, from our committee will continue to support our work with Scottish members. Contact, stewart@caledonianldt.com
- The GFM Helping ADIs and PDIs account will continue to receive our help and support and as I write this the total is £20,220. I'm getting slightly addicted to looking to see what has happened to it during a day because I'm extremely proud with the way in which ADIs are helping other ADIs in such challenging times. The ultimate goal is for this fund to continue to run once the pandemic is over to help ADIs at any time they are facing hardship and need for various reasons.
- Our social media channels will be there for you to keep up to date and enter discussions.

For any of the above to be taking place takes time and effort and please remember the **ADINJC** is formed by a committee of volunteers. Our team works exceptionally hard all of the time but during the pandemic has worked tirelessly to support members and non-members way beyond what is normal and I thank all of them for their perseverance and help, it's truly inspiring.

Obviously we do receive feedback from you and we take it on board and endeavour to act on it if we consider we can and after discussion as a team. However can I be clear that we will not enter into email discussions that are frankly rude, unhelpful or intimidating even though we understand at times this may happen through sheer frustration from members? Neither will we tolerate any other members being ridiculed or belittled on social media, posts will be monitored and removed if in our opinion it's necessary to do so. Go Fund Me - Helping ADIs and PDIs:

Bobbie Hicks and Susan McDonald are 2 ADIs who have set up a fund to help others who are struggling financially. In these trying times everybody needs a little help and if the Government cannot help us all, then the least we, as ADIs can do is help each other and share what little we do have. By doing so we also show those less fortunate that we care about the predicament they are in. They are asking ADIs and Driving Schools if they could donate as little as £1 (more if possible) to a fund to help instructors who will not receive Government assistance. We all know it is hard for everybody at the moment, but with around 39,000 ADIs on the register, if everyone was able to donate £1 to this fund it would show that while we may work alone and vie for the same customers, we don't have to be alone when we need help.

I am thrilled to say that the NJC will be joined by DIA and MSA to help support Susan and Bobbie in promoting the fund. It really is time to get the whole industry involved in this excellent initiative. Grants will be considered by a panel, consisting of some of the members of NASP. The panel will be unaware of the identity of the applicant, who will have had to provide supporting evidence of their need. Small grants will be made and will be on a one off basis only. There will be an independent person, not an ADI, to monitor and audit the income and expenditure and bank account. No expenses will be taken by the organisers or by the panel, all monies received will be for the fund to help ADIs and PDIs, other than any bank charges that may be incurred. Payments will be made via bank transfer into the recipients' bank accounts.

Although this fund has been set up as a result of Covid-19, and to help people through the current situation, it is hoped that if funds can be secured on an ongoing basis this project can continue to help those in our industry who need it in the future. Currently as I write this the fund stands at around £20,200. We must thank Marmalade Insurance for their kind donation of £10,000 and for inspiring others to join in. 

NASP Update on Driver & Rider Training and Testing - 6th Jan 2021

We are aware that the announcement of national lockdowns in England, Scotland, Wales, and Northern Ireland will be of grave concern to the industry. As we have throughout the COVID crisis, NASP will work together to provide guidance and information to the training community as well as consulting directly with DVSA and other key stakeholders to address the concerns of the industry. Via your respective membership associations, please keep feeding in your questions and issues so we can raise them with the relevant stakeholders.

The details of how this lockdown impacts testing and training, and for each country, are detailed below with live links wherever possible, in these ever-changing times we in NASP will keep you updated as new information becomes available to us, all relevant information can also be found on the NASP website http://www.n-a-s-p.co.uk/

This is the latest information available regarding driver training and testing in England, Scotland & Wales as of 6th January 21, we will update you as any further information becomes available.

DVSA Guidance

DVSA have issued guidance that Driving and Riding lessons, including CBT must not take place until the restrictions are lifted. This includes ADI part 2 and 3 tests and standards checks.

Country restrictions

England

You must not provide driving lessons or motorcycle training in England unless it's with someone from your household during an essential journey because of the national lockdown.

Scotland

You must not provide driving lessons or motorcycle training in Scotland unless it's with someone from your household during an essential journey because of the temporary lockdown.

Wales

You must not provide driving lessons or motorcycle training in Wales unless it's with someone from your household during an essential journey because it's in alert level 4.

Check if driving or theory tests are taking place

England

All types of driving tests are suspended in England because of the national lockdown.

Scotland

All types of driving tests are suspended in Scotland because of the temporary lockdown.

Wales

All types of driving tests are suspended in Wales because it's in alert level 4.

If your driving test is affected

DVSA will email candidates who are affected by this to let them know they will reschedule their

If you have booked a test for any of your pupils, you will receive an email from DVSA to let you know it will be rescheduled to a new time and date. You will need to contact your pupil to let them know.

DVSA will then send you an email with the new time and date as soon as possible; please ask your pupils to be patient.

If the new time and date is not suitable for you or your pupil, you can choose a different time and date on GOV.UK. You will need your pupil's driving licence number to do this. Your pupil does not need to pay again to do this.

Theory tests

All theory tests will be suspended by DVSA until the restrictions are lifted.

DVSA will email anyone who has booked a test and is affected by this to let them know their theory test is on hold and that they will need to reschedule it by visiting https://www.gov.uk/change-theory-test.

If you booked your pupil's theory test for them, you would need to log into the booking system and rearrange their test for a new date and time.

Find coronavirus financial support for your business

Coronavirus (COVID19) support is available to employers and the self-employed, including sole traders and limited company directors. You may be eligible for loans, tax relief and cash grants, whether your business is open or closed.

If you cannot pay your tax bill on time

Contact HM Revenue and Customs (HMRC) as soon as possible if you are struggling to make payments. If you did not make a Self-Assessment payment on account due in July 2020, your payment deadline will have been delayed (deferred) until 31 January 2021. You do not have to contact HMRC and will not have to pay a penalty.

Some questions we have jointly already put to DVSA

Q: Some newspapers have suggested driving instruction can go ahead during this lockdown in England, is this correct?

A: This was misinformation and incorrect, driver testing, or training is not allowed at this time

Q: Is key worker training or testing allowed?

A: At the moment neither is allowed, however the situation is being kept under review.

Q: Is fleet driver training allowed

A: Awaiting confirmation from DVSA 6th Jan



Q: Is vocational training and rider instruction allowed?

A: We wrote to you earlier to confirm that all driver rider and vocational testing and training must stop until the restrictions are lifted.

Q: Is emergency service testing allowed?

A: During the new national lockdown we will work with ambulance trusts to provide them with essential emergency service driving tests

O: Is driver CPC allowed?

A: Driver CPC training should be done remotely. This will be kept under review

Q: What will happen with test cancellations?

A: We will continue to reschedule tests cancelled as a result of the lockdown and candidates will be moved to the first available date. All tests will be rescheduled while the restrictions are in place and we will continue to keep the Government guidance under review.

Q: Can delegated testing continue?

A: All vocational and car driving tests and theory tests will be suspended until the restrictions are lifted. As a result, all HGV delegated testing will be suspended whilst the restrictions remain in place. Delegated testing for those running public service vehicles may continue where necessary.

Q: Is private practice allowed?

A: Government guidance during the lockdown is to stay at home so private practice not advised until the restrictions are lifted.

NASP starts a campaign to extend theory test certificates

11th Jan 2021 - Update on Theory Test Certificates

A letter (see opposite page) has been emailed to Grant Shapps Secretary of State for Transport, Baroness Vere Under Secretary of State for Transport, and Loveday Ryder CEO DVSA with senior DVSA staff included to encourage a change in the law to extend the expiry date on theory certificates.

We would also like your help to strengthen this request, we have included a link to a specimen letter (see opposite page) for you to send direct to your own MP, If you are not sure of your MPs contact details, click this link: https://members.parliament.uk/members/Commons

You may also want to ask any candidates with certificates about to expire to use the content, however, they will need to change the line to start with... I'm writing as a candidate who has a current theory test certificate that is about to expire.

If we work together, we can right the injustice that our pupils are going to face yet again.

More about Susan McDonald and Bobbie Hicks

My name is Susan McDonald and I am a self-employed Driving Instructor from Billingham in Teesside. Since my partner died in 2006, I have been a single parent to 3 amazing boys (actually, they are now men - but they're still my boys)! Prior to being an ADI, I spent my working life in various offices working in administration and financial roles until I was made redundant and my



father died shortly after. At this point I realised that there was more to life than sitting in a boring office all day and that now was the time to make the change and do something I actually wanted to do and not something I had to do to make ends meet. Many, many years before I had wanted to become a Driving Instructor, so I decided that it was now or never.

In my 'spare' time, for over 30 years, I have been a volunteer of a Registered Charity which is the local branch of the National Charity Phab. During this time, I have held the positions of treasurer, administrator, Assistant Chairperson, fundraiser, leader, and organiser and I am currently the Person In Charge of the Charity and also the Manager of the Community Centre which we have the lease of. In my younger days I was also one of the founder members of the Phab Youth Council.

During the first lockdown I noticed a lot of ADIs/PDIs were saying how much they were struggling to make ends meet as they were not entitled to any financial help and were unable to earn a living due to restrictions imposed. Some of these people were really struggling and seemed quite desperate. At this time, I thought that there must be some help somewhere for these people, but there was nothing for so many of them and I wished I could help them in some way.

In November, as we entered a second lockdown I noticed a lot of people again starting to worry about how they were going to survive yet another lockdown without help and started to think of a way I could help. I decided to ask a small Facebook group for their opinion on setting up a fund to help the 'forgotten ones' and found that many people were willing to donate. Bobbie Hicks got in touch with me and we discussed how this could be possible and if the fund could actually help people and we decided it was 'worth a try' so together we set up a Go Fund Me page. Within the first few days the fund had raised almost £300.

The main aim of the fund is to ask fellow Driving Instructors, family and friends if they could donate any amount to be able to provide a little financial assistance to fellow ADIs/PDIs who find themselves in financial difficulty through no fault of their own. There will be a strict selection process to ensure that the funds are allocated fairly and to the people who really need them.

Bobbie Hicks:

I have been a driving instructor for about 27 years, during that time I have taken further training to become an Accident Investigator and then later a Fleet trainer. For a while during the second lockdown, I was thinking about setting up a Go Fund me page to help all the ADIs and PDIs whose stories I was coming across on Facebook. I saw Susan McDonald's post about a similar idea and contacted her and this project was started. It seems like a scary thing to do, but we cannot live in fear, so we took the bull by the preverbal horns and launched the Go Fund me page.

We've both been bowled over by all the donations and help so far, which we are most grateful for.

General Information:

- The money is held by Go Fund Me for 60 days then needs to be transferred to a bank account. This account is now set up as a community bank account.
- Although Susan and Bobbie would very much like to achieve the target they set, we are also
 aware that this is a large sum. We think it best therefore to not actually work towards a target,
 but just try to raise enough to be able to help. We would like to see this as not just a 'one off'
 fund which is just set up to cover the COVID-19 Pandemic, but an ongoing fund to help any
 Driving Instructor, anytime, whenever they may need it.
- The hope is to be able to help people as soon as possible, the first step being to get a sum to work with in the account.
- The amount awarded to each individual will depend entirely on the circumstances of the person and the funds available. A panel will be set up to oversee who the funds are donated to.

As we make payments there will be less in the fund, which will be the amount in the bank balance and not what is shown as the total donated.

Can I only donate through the Go Fund Me page? Donations made through the Go Fund Me page will be the only ones that will show in the total on that page. However, donations can also be sent direct to the bank account at: Bank – NatWest, Account Name – Helping ADI & PDI's, Sort Code – 54-21-54, Account No – 35283769. This account can also be used to set up longer term contributions such as Direct Debit or Standing Orders.

Why was the fund set up? The Scheme was set up in order to provide monetary assistance to help an ADI or PDI at any time for any just reason including, but not limited to, lockdown measures from COVID-19, hardship, bereavement or illness. It was launched with a focus on ADI and PDI's who are unable to qualify for government assistance (e.g. SEISS) or local council grants during the pandemic.

Who started it and who is in control of it? The fund was started by two ADIs who wanted to help other colleagues. Bobbie Hicks and Susan McDonald realised that many ADIs and PDIs were struggling financially and wanted to help, so set up this fund. It started off slowly but with the help of the industry it has now reached over £20,000 in total and is still growing. The scheme is supported and associated with NASP (The National Associations Strategic Partnership) which comprises of the 3 leading national associations for driving instructors: ADINJC, DIA and MSA GB.

Why have NASP become involved? NASP have become involved in the scheme to help promote the fund, give support and offer advice. This also means that the fund will be able to reach as many ADIs and PDIs as possible through the 3 national associations that comprise NASP. Also, Bobbie and Susan will have support for the scheme from a well-known and established organisation which can spread much wider and, we feel, gives it more credence. Do I need to be a member of a NASP association to apply? You do not need to be a member of a NASP association to make an application. More details of each of the 3 associations are available on their website www.n-a-s-p.co.uk

Where can I find the rules for the fund? The rules for the fund can be found on the website, by email and on the Go Fund Me page and are also available from each of the 3 associations of NASP. www.instructorfund.org

What amounts will be paid out? Payments will depend on the number of applications we receive and the amount available in the fund at the time. They will be small grants usually of £100 but in some circumstances they could be as much as £500. The grants paid out will not exceed £500. Funding amounts available will be at the discretion of the funding panel and their decision is final.

What is the process if I want to apply? An initial application for funding is to be made by email to support@instructorfund.org.

An application form will then be sent to the applicant by return. All applications must be received on this form and completed in full. A third party, such as a local group committee member, may suggest that someone may be eligible for assistance. That person will then be sent an application form. In the event of an application due to lockdown measures, the person to receive funding must have exhausted all mainstream options of support, including but not limited to Universal Credit, SEISS, Bounce Back Loans and local authority grants. Those in receipt of Universal Credit or other support may still apply if they can provide proof that they are unable to cover their personal living costs.

Can this fund be used to back up my business?

No, all funds are given on a personal basis and are to be used for living costs

What evidence will I need to give?

The application form must be accompanied by:

- an up-to-date copy of the applicants green badge or pink licence
- any relevant documentation requested or to support the application
- evidence of refusal of government support
- a brief explanation of the reasons why the ADI/PDI believes they are suitable to apply for assistance from the fund
- Bank account details (This must be a UK bank account)
- A copy of the applicants driving licence or passport for photographic evidence

The Panel reserves the right to ask for further supporting information in the pursuance of an application for funds.

How long will the process take? This process will take a maximum of between 4 and 6 weeks.

Will my application be confidential? Yes, all information will be kept confidential and in compliance with GDPR. The panel will keep a copy of each application form submitted for up to three months after final assessment for funding has taken place.

After the application form is received, it will be checked and made anonymous before being given to the panel to make a final decision.

Who is on the panel? The Panel will comprise of Susan McDonald and Bobbie Hicks the organisers. It will also have at least 5 members of the NASP association which comprises the ADINJC, DIA and MSA GB. These members will come from the committees or be senior representatives of each association.


How will I know if I am successful? A member of the panel will inform the ADI/PDI by email and/or telephone if their application has been successful.

How will the amounts be paid out? Payments will be made directly into the nominated account on the application by bank transfer from the account held by the fund.

Are any expenses taken by the organisers? No expenses will be claimed or paid to any member of the panel or members of NASP. The only charges envisaged would be any bank or Go Fund Me charges incurred. Thanks must go to all the volunteers who have helped make this possible for their time and support.

Is this fund just for the period of COVID-19? Although this fund has been set up as a result of Covid 19, and to help people through the current situation, it is hoped that if funds can be secured on an ongoing basis this project can continue to help those in our industry who need it in the future.



Public Liability Driving Tuition

Why is Public Liability cover so important?

Because we all make mistakes in life, including in our business operations as a driving instructor. Quite simply, if a member of the public (or any other third party) is injured or suffers damage to their property, arising out of the conduct of your business as a driving instructor, you could be held responsible.

The ADINJC Public Liability insurance, is designed to provide protection from claims against you by third parties who may have suffered personal injury or damage to their property, during contact with your driving school. Most motor policies provide you with a compulsory £20 Million Public Liability cover for accidents and injuries that occur as a consequence of having an accident. The ADINJC believes it's important to ensure you also have sufficient cover away from the vehicle, and have therefore arranged for its paid up members to benefit from £10 Million Public Liability cover away from the vehicle. The policy also has a low policy excess of just £500 for each and every claim. The ADINJC policy provides £10 Million cover for each and every claim during the life of the policy.

A range of claims can arise. These can extend from accidents at your own business premises, to incidents that occur whilst providing advice or tuition whilst working away from your vehicle.

Increasingly, it is a requirement of many customers, principals, and clients (particularly local authorities and government agencies), that you be asked to present proof of Public Liability insurance before they will work with you, or allow you to work on their property or premises.

Compensation arising from Public Liability claims can be substantial, and may include loss of earnings, future loss of earnings and damages awarded to the claimant. In addition, considerable legal costs in defending the claim can be incurred, and the claimants' legal costs may also be awarded against you if you are found to be at fault. All would be covered under a comprehensive Public Liability policy

Claims for trips, slips and falls are the most common, but there are other events that can lead to a claim against you. The following are examples of potential claims that can give rise to public liability claims against your driving school:

- you open your door for a pupil who you inadvertently trip over, causing an injury;
- you spill a hot drink in a classroom and a pupil slips over on this, causing an injury;
- a pupil falls over some cones you have positioned to practice parking, causing an injury;
- · you knock over a valuable antique whilst waiting for a pupil at their home;

Your questions for DVSA

Recently answered questions in advance of our Covid-19 webinar, courtesy of Mike Warner, Senior External Affairs Manager, DVSA

1. What is the reasoning behind the decision on private practice being stopped in England please? This will only result in lots of 'rusty' candidates arriving for test when they reopen? Seems strange that it is okay in Scotland and Wales, but not in England. Whilst ADIs can tell their pupils and send them to the gov.uk website link will there also be announcements to the public made on this? We understand learners who have booked their own tests have received a message on the cancellation emails (this is not on emails to ADIs who book the tests).

Government guidance is very clear that people should be staying at home to save lives and protect the NHS unless the trip is essential. A journey solely for driver learning purposes is not considered essential. However, current guidance has been reviewed and updated. Because of coronavirus (COVID-19), you can only practise driving with members of your household or support bubble as part of travel for work, education or other essential journeys. This position is the same in England, Scotland and Wales.

2. Are DVSA going to reconsider any decisions to date on extending the theory test certificate extension now this pandemic is going on for so much longer than was originally envisaged?

To clarify this is not a DVSA decision to make, the theory test certificate validity is set out in legislation and as such there is no discretionary flexibility available for DVSA, DfT or, indeed, the Minister. If such a change were to be made it would require legislative amendment in parliament. I understand there have been comparisons made to the MOT extension, but we would highlight that this is already permitted in the legislation, thus merely required ministerial approval.

3. What help are the DVSA providing PDIs now who are in such a difficult position with their Part 3 exams and their trainee licences? Since March 20 when we went into the first lockdown until the end of March this year we are likely to have been unable to work or train for 8 out of the 12 months. Are the DVSA going to extend PDI part 3 tests as time critical candidates are close to cut off date for taking their part 3. Decisions such as "ultimately I need to decide whether to lose time on the second pink and return to work as soon as lockdown is lifted or lose time returning to work when lockdown is lifted waiting for pink to arrive" are common and difficult for PDIs. What advice can you give PDIs.

Driving instruction is a regulated profession and as such the role, including the qualification process is governed by legislation. The Registrar can do only what parliament has granted the powers for them to do. We cannot just choose to ignore regulations, but we are working with as much flexibility as we possibly can. Regulations require that a part 3 test is booked, not taken, before the expiry of the part 1. PDIs whose part 1 pass is due to expire soon can book a test online. If no tests are available they can book a test to hold, which means paying the fee and we will arrange a test booking when tests become available. This meets the regulatory requirements. We are advising anyone whose trainee licence commenced at the start of January that they can ask for the licence to be re-issued when restrictions



are lifted. Anyone in that position should contact the ADI team at PADI@dvsa.gov.uk and we will advise them of their options. Similarly, any trainee whose licence is due to expire in the coming weeks should also seek advice from the ADI team. We are encouraging trainees not to apply for a licence they know they cannot use, however, we need to take into account the regulatory requirements so advice for one trainee may not be appropriate for another so each should seek their own advice from the ADI team. Once restrictions are lifted, trainees should give us as much notice as they possible can when they want their licences to start. We will prioritise these and it is likely they will be issued the same or next working day. Once issued we will send the trainee an email that tells them that they can teach for reward. This is the same process that we used when restrictions were lifted in the summer.

4. PDIs with Part 3 exams in January which are cancelled are getting them again for the beginning of March? How do we know those will take place or will they be moved again?

We will continue to take direction from Government regards length of the lockdown and the gradual phased reduction in restrictions once infection and death rates decline. It is a possibility tests may have to be moved again.

5. Some test centres that are meant to be closing down should surely be staying open to help with the testing process once we are able to work again? Will DVSA consider that an example being High Wycombe due to close in March.

Driving Test Centres close for a variety of reasons some we have control over, some we do not, for example lease ending at Brislington. In consultation with staff, and trade union representatives, Driving Examiners will be redeployed to nearby DTCs to maintain the same testing capacity.

6. Standards Checks - will the DVSA now cancel all routine ADI SC's for the foreseeable future (not just December/January as was originally communicated) and concentrate on those examiners conducting Part 2 & 3 tests only?

We will consider the continuation of the policy to cancel routine SC's, prioritise P2 & 3 and have 50% of warrant card holders time prioritised to frontline testing. Our focus since Monday 4th January has been suspending services, responding to changes in Scotland & Wales and getting communications out. We will begin considering impact, restart principles (as we don't yet have a date) and longterm recovery over the coming weeks. We will consult with NASP throughout this process.

7. As we have paid our fees for our ADI licences surely we should all be compensated for the time that we haven't been able to teach?

As per Question 3, driving instruction is a regulated profession and registration is governed by legislation. There are no powers to extend the registration period beyond 4 years, nor to waive the fee.

8. What plans are being made by the DVSA to deal with the incredible backlog of tests? In my test centre - Crewe it's a 20 week shift from cancelled test for today to new booking in May. This waiting time will continue forever as more turn 17 each week unless tests are done at a higher frequency than they were in the past. Are they recruiting more examiners at the moment? Or will a 5 month wait for a test be considered acceptable going forward as a result of a pandemic? Recruitment and training could be done in a Covid secure way for the most part and if they don't plan ahead to increase their headcount above where they were before this pandemic the waiting time for tests will inevitably lead to unlicensed drivers who just won't bother taking a test.

Our focus since Monday 4th January has been suspending services, responding to changes in Scotland & Wales and getting communications out. We will begin considering impact, restart principles (as we don't yet have a date) and longterm recovery over the coming weeks. As mentioned in Q6, we have already redeployed 50% of ALL warrant card holder time to frontline testing. One of our biggest priorities in 2021 will be frontline service recovery, while keeping our staff and customers safe.

9. ADI access to the booking system: Isn't it now time to either limit access to the booking system to ADIs only or at least ensure that all ADIs can access it? I understand it's only a small proportion that use it, all should have access to the system, this could be set up now in the time when no tests are taking place. There will be an excuse that the public should be able to access it if they haven't learnt with an ADI but the pandemic has changed the rules on so many things that surely this change to only booking a test through an ADI would improve the pass rates and improve road safety.

We operate two booking systems – Internet Booking System (for public bookings) and Online Business Service (for ADIs to book on behalf of their candidate) – both linked to a central database of test slot availability. The vast majority of tests are booked via the IBS1 system, we have no intention of restricting this. Regards OBS, this is not an exclusive system; any ADI is welcome to join OBS, any and all ADIs can access it. You can register via https://www.gov.uk/register-book-driving-tests-for-pupils

10. Why aren't face coverings now compulsory in driving lessons now this pandemic is getting worse?

Of course lessons are suspended at present, but a reversal of this question could also be proposed; should government need to legislate for something like this? The Prime Minister and Chief Medical Officer have repeatedly highlighted the dangers, public health campaigns have communicated the importance of Hands, Face, Space to cut the chain of transmission, and DVSA have communicated the importance of face coverings to every ADI through our SOPs, DVSA Directs and NASP webinars. DVSA made face coverings compulsory for driving tests under health and safety legislation to protect our workforce; ADIs may choose to do the same. As a professional, regulated, industry it should not be necessary for government to legislate; but rather should inform, advise and encourage, as we have. As independent businesses ADIs must conduct their own risk assessments and consider appropriate protections under health and safety, we would strongly encourage the use of face coverings in England and Wales; it is law in Scotland. It should also be noted that exemptions do apply due to health, physical or mental conditions.

Clarification regarding private practice

Government guidance is very clear that people should be staying at home to save lives and protect the NHS unless the trip is essential. A journey solely for driver learning purposes is not considered essential. However, current guidance has been reviewed and updated. Because of coronavirus (COVID-19), you can only practise driving with members of your household or support bubble as part of travel for work, education or other essential journeys. This position is the same in England, Scotland and Wales.

Well, as this is my first column of 2021 (and, appropriately, I am writing this bit on the morning of January 1st) I will take the opportunity to wish you an incredibly Happy New Year. The first story, however, goes back to November 18th last year when the Mail's front page headline was 'END OF ROAD FOR PETROL AND DIESEL CARS IN JUST NINE YEARS'. It said that Boris Johnson was due to announce that sales of new internal combustion engine cars are to be banned in 2030. Paving the way for an electric vehicle revolution, he is to unveil a ten-point, £12billion plan for the environment. It includes further investment in nuclear power, wind energy, domestic heating and cutting-edge technology such as carbon capture and storage. The petrol and diesel ban is to start in nine years – a decade earlier than originally planned. The Prime Minister will herald a 'green

cutting-edge technology such as carbon capture and storage. The petrol and diesel ban is to start in nine years – a decade earlier than originally planned. The Prime Minister will herald a 'green industrial revolution' that could create 250,000 jobs and slash the country's carbon emissions. However, with electric vehicles costing far more than conventional models, the plan could hit the poor. A leading economist warned the switch would put £40billion in road taxes at risk because electric vehicles are exempt. "Some form of road pricing will be needed," said Paul Johnson of the Institute for Fiscal Studies. "The Government needs to get started now – it will be very hard to introduce after people have got used to no tax." Nicholas Lyes of the RAC warned that many motorists would be nervous about the switch to electric cars, given their limited driving range and charging problems. Urging ministers to revive discount schemes for buyers, he said the biggest barrier by far was the high upfront cost. The push for electric vehicles will come with a £1.3billion investment in charging points in homes, streets and trunk roads. Well, Mrs Adrian has a hybrid Kia Nero and my next daily driver will be the hybrid Suzuki Swift Sport which has just been announced.

And there was an interesting twist in the continuing saga of the smart motorways in the Mail of December 22nd. The story said that Highways England could face manslaughter charges after a grandmother was killed in an accident on this type of motorway. A coroner investigating the death of Nargis Begum, 62, has said she is considering referring the matter to the Crown Prosecution Service in what would be a landmark case. Mrs Begum was being driven by her husband Mohammed Bashir, 67, down a 'smart' stretch of the M1 in South Yorkshire. She got out of her Nissan Qashqai to wait for help, but another car hit the vehicle, sending it ploughing into her. A pre-inquest review heard that warning signs on the motorway had not been activated in time to stop drivers entering the lane where the couple had broken down. Coroner Nicola Munday, sitting in Doncaster, heard that 16 minutes and 21 seconds elapsed between the Nissan breaking down and the collision, and it took a further six minutes and 15 seconds before warning signs were activated. The coroner said: "I want to know why, essentially. It's as simple as that."

Are you old enough to remember Knight Rider? I'm afraid that I am. There was a piece in the Mail of January 7th which said that whether he was bounding through the surf or roaring across the desert in search of baddies, David Hasselhoff has always been larger than life. There was one character, however, who always upstaged him – his talking car KITT. Now one of the black 1982 Pontiac Firebird Trans Ams used in the Knight Rider series is going on sale in an online auction – among a host of 'Hoff' memorabilia. It includes a pair of signed red shorts like the ones he wore while playing shirtless lifeguard Mitch Buchannon in Baywatch – and a 14ft model of himself with an estimated price tag of £1.1million. But for Knight Rider fans, the big-ticket item has to be the 'fully functional' KITT car, which

the US actor, 68, said he will personally deliver to the buyer if the bid exceeds the £220,000 estimate by 25 percent. The Live Auctioneers sale closes on January 23rd. I wish that I could afford to bid.

And there was a story in my local regional daily, the Western Morning News of December 14th, which said that a new survey suggests that pothole-plagued local roads are the UK's most widespread motoring concern. An RAC poll of 3,068 drivers indicated that 38% are agitated by the condition and maintenance of local roads. This up from 33% in 2019 and is ahead of other issues such as motorists using hand-held phones (32%), the standard of other people's driving (27%), and the aggressive behaviour of other road users (26%). More than half (52%) of those surveyed believe local roads are worse than 12 months ago, compared with 49% who said this in 2019. Only 6% of drivers think that conditions have improved. Motorists based in rural areas are more likely to say local roads have worsened (59%). Separate RAC data shows it received 1,871 call-outs for pothole-related vehicle damage between July and October, which is the highest number for those three months since 2015. RAC head of roads policy Nicholas Lyes said the figures are "a big concern" as last year's relatively mild winter was not expected to have led to a further decline in road surface quality. Well, there we all are then.

And a recent edition of Auto Express had an update on the electric vehicle issue. The magazine said that, in addition to all new conventional petrol and diesel cars and vans being banned from sale from 2030, new hybrids will be banned too, unless they can cover a 'significant distance' in zero-emissions mode. While unfortunately, no clarification has been provided on what counts as a 'significant' zero-emission range, new plug-in hybrids will remain in showrooms for another five years, before being outlawed in 2035. The Government has also confirmed that it will allow conventional hybrids to remain on sale until then as long as they can achieve the 'significant' zero-emission distance. (I hope you are following all this – there will be questions later). After 2035, the only new cars and vans that can be sold will be purely electric or powered by hydrogen. Second-hand cars will not be affected by the ban, allowing petrol, diesel, and hybrid cars to change hands on the used market after 2030. A consultation will also be launched on phasing out diesel HGVs. Good grief!

There was a piece in the Mail of December 8th which said that the first green number plates will be fitted to new electric vehicles from that date. The plates are like standard white and yellow versions but with a vertical green stripe on the left side that can be identified by cameras. Ministers want local authorities to reward green plate owners with benefits such as permission to use bus lanes. They are also looking at whether parking spaces could be painted green to give priority to zero-emission vehicles. While the plates will now be fitted to new electric vehicles, existing owners will also be able to apply for them. Only fully electric vehicles will be able to display them, with hybrids and plug-in hybrids ineligible. It came as the country's first forecourt for electric vehicle charging opened in Braintree, Essex. It is part of a £1billion plan for a nationwide network of charging stations as the Government pushes for greater uptake of zero-emission vehicles. Green plates have been criticised by the pressure group FairFuelUK, which fears they could be used to 'demonise' petrol and diesel owners. Like me for example.

And talking about number plates, it has been some months since I wrote about one of my favourite subjects, has it not? Well, there was a story in the Mail on Sunday of January 3rd which told how there has been a surge in demand for personalised number plates during the pandemic – turning many of them into shrewd investments. The increase in sales has helped the value of the most soughtafter plates rise in price, creating a multi-million-pound industry where they can change hands for


anything from £150 to £200,000 - or more. Russell Palmer is a director of plate trader CarReg. He says: "With so many people forced to work from home, there has been a boom in business – with people discovering that personalised number plates can prove shrewd investments. Thanks to regular online auctions and sales, there is no need for buyers to step out of their front door." Interest is fuelled by many people wishing to personalise cars with a registration that means something special to them – with letters and numbers that look like they spell out a name or cherished word. Those plates rising most in value include forenames that have attracted a growing popularity. Jack is a Christian name that has been popular among new parents in recent years. A registration plate 'IAC 1K' that sold for £8,700 in 2008 could now sell for as much as £50,000, according to Palmer. Registration plate 'MEG 4N' went for £12,500 in 2003. But following the marriage of Megan Markle to Prince Harry, it has since been valued at £45,000. Another winner is the plate 'BOR 15N' that was snapped up for £650 in 2013 but sold last year for £2,000 - after Boris Johnson became Prime Minister. Plates go back to 1904 when it was first required to have a vehicle registered. Early registration plates before 1963 – after which date recognition letters at the end of the plate (suffix) came in – are most sought after. These so-called 'cherished' plates come with a combination of up to three letters and four numbers. Low combinations are the most valuable. Such examples can sell for £100,000 or even more. Palmer owns car registration plate number '1 RP' that he inherited from his late father who shared the same initials. The plate was bought for £10,500 in 1995 and is now valued at more than £150,000. He says: "It can be particularly appealing if you have a name such as mine that has been passed down through the family – as it means something special." Between 1963 and 1983, plates had age identifiers at the end. This was switched in 1983 to be at the front of the plate (prefix) and this practice continued until 2001. Since then, the third and fourth digits on a plate have been used to identify the year of a car's registration – changing every six months. In March it becomes '21' and then in September '71' - 21 plus 50. So, what have been the top prices paid for number plates? '1' was purchased by Abu Dhabi businessman Saeed Abdul Ghaffar Khouri in 2008 for £7.25million. '25 0' was bought for £518,480 by Ferrari dealer John Collins in 2014. The plate sits on a Ferrari 250 SWB once owned by rock star Eric Clapton. 'F1' was snapped up by Bradford based businessman Afzal Khan in 2008 and placed on a Bugatti Veyron sports car. And Chelsea Football Club owner Roman Abranovitch bought 'VIP 1' for £285,000 in 2006. It came from the Irish town of Kilkenny and the number was used on a vehicle to transport Pope John Paul II on his 1979 Ireland trip. And me? I am so glad that I decided not to sell 'M5 PSL'!

And finally,

Driving Instructor Insurance - features explained

Any Driver Cover - It is essential for your policy to be issued on an any driver basis; this allows you to teach any licensed driver on the road irrespective of previous driving experience or other risk factors. This also allows the examiner to drive if required, as you will not be able to provide his or her details to your insurer prior to your pupil taking their test.

Replacement Dual Control Vehicle Cover - As a business car insurance policy it is important to ensure you get the correct replacement vehicle suitable for your needs. Most standard car insurance products will only offer you a non-dual controlled car in the event of a non-fault incident meaning you're unable to continue working. Many specialist driving • Additional speedo instructor insurance providers will provide you with a dual controlled vehicle in the event of a claim. You should try to find a provider who will supply you with a guaranteed dual control replacement car within 24 hours to enable you continue teaching and sit any pre-booked driving tests. You should also consider how long you may need this vehicle for many providers will only supply a vehicle for a limited period try to find a provider who offers

Negligent Tuition Cover - This cover extends you're driving instructor insurance policy to insure you and any driving instructor engaged by you to whom you have provided a vehicle which is insured under your policy, for your/their legal liability to pupils whilst driving instruction is being

Driving Off Road Driver Aged 14+ - Some driving instructor insurance policies provide extended cover to allow you to teach pupils off road who are aged 14 or over. This cover is only provided where it can be evidenced that the land you're using the vehicle on does not form part of policy and provide cover suitable for your needs.

Cover for Hire & Reward - As a driving instructor you will be collecting money for giving lessons whilst carrying your client in the vehicle this requires hire and reward to be included within your policy for the purpose of driving tuition and test. Standard private motor policies will not include this type of cover.

Most standard car insurance policies will class these as modifications and will therefore not be able to provide cover. It is important to mention these to your insurance provider so that they then can note these on your
