From the Chair..... a monthly report



As I write this in England we have just gone into a second lockdown and we are

in a position where each of the four nations are under different rules and guidance. This brings pressures for us all as ADIs and for our families and loved ones, not just financially but with mental anxiety and the stress of how to cope. I'm sure in England we are all hoping it will just last a month and that the R rate will drop again to safer levels. In the first lockdown I was well aware of the daily news and figures of people contracting Covid-19 but I actually never knew anyone personally who had been ill with it. What I am now aware of is how that has changed and as I talk to friends and family it all feels much closer to home and I was starting to feel more at risk going out to work in the car. Obviously we have had a lot of phone calls and emails asking us all sorts of related questions to this second lockdown. I was pleased to see that the initial guidance from DVSA when it came out was clearer and stated:

Following the announcement on Saturday 31 October 2020 around further lockdown measures being introduced in England, we are working closely with the Government to agree the impact these will have on DVSA services. All driver and rider training and tests will be suspended in England from 5 November until 2 December 2020. We will be contacting affected test candidates soon.

We then had more information from DVSA after which I released a statement to say:

"I want to thank the team at NJC for working the late hours to get out information for you. Having finally got more information from DVSA late last night for restrictions in England, it restated that Government guidance directs that for the duration of the lockdown driver and rider training lessons should not take place. This is in the interest of everyone's health and to protect the NHS.

It also clarifies:

- There will be no critical worker tests and ADIs and PDIs are advised not to provide critical worker lessons. It does state this will be kept under review
- Candidates should not travel into other parts of the UK to take tests and will be refused.
- The advice is for cars and motorcycle training
- Candidates who have practical tests cancelled will be contacted and sent a new date by DVSA
- Unless the lockdown is extended the date to resume work is December 2nd as lockdown ends at 00:01 on that day.

We are aware there are still many questions that members need to have answered and we will endeavour to get these to you as soon as we have them from DVSA in the coming days. The **ADINJC** would urge you to follow the Government Guidance.

If any of you choose not to follow this guidance you should seek confirmation from your insurers regarding your cover".

The NJC and NASP will endeavour to send out a list of FAQs and help you with the issues you have raised around vocational training, pink badges, green badge renewal, how candidates will be able to book another test to name just a few. We were hoping to have the answers to the questions we sent to the DVSA as NJC by the time our webinar went live on the Monday evening at the start

of November. I can assure those people who were quick to say we got the timing incorrect for the webinar that we had no reason until literally a few hours before to think we wouldn't have the answers from DVSA as we had liaised with them throughout the day. I was pleased therefore to still be able to hold the webinar successfully and for the support from all the people who attended and listened in.

These are difficult times for us all but the last thing we need is to have a divided industry falling out amongst ourselves, we need to support each other and be kind to each other even though we may have different views we need to be tolerant of each other. It has been an extraordinary time for us all and we have tried hard to support all 4 nations during coronavirus but I don't mind admitting that has become harder as time has gone on. We will do our utmost to support you all and I want to thank those of you who have also helped us by staying in touch, helping with information and sending us messages of support. We accept any feedback we are sent and do our best to act on it after careful consideration.

Thank you for all the messages and this recent one below sums up a message I want to convey to the team at NJC who work so hard to run the association. It was placed on Facebook by a member:

The **ADINJC** have been with ADIs throughout this whole epidemic, they've advised us, supported us, and done everything they can for us for which I'm truly grateful. When we find out what affects our industry this time around these unsung heroes who have championed our corner, will be there to help and advise, thank you from the bottom of my heart.

Another said: No matter of the time of day or evening whenever I have tried to contact the ADINJC, there has always been someone there who has responded straight away. Such commitment is rare, but always appreciated. Thanks for everything.

In response to the recent events with coronavirus we have set up our talk line again for anyone who needs help in coping in these difficult times. We will hold any webinars we feel necessary during this month and we wrote letters immediately to the Chancellor and the Business Secretary after hearing the news from the Chancellor on what is available for the self-employed. We understand many of you who are newly qualified and haven't got the relevant accounts to show are falling through the cracks and are not receiving financial help.

AGM and Association Meeting by Zoom:

More details of our AGM and Association Meeting to be held by zoom on Saturday December 5th are in this newsletter. This is an important meeting for us and if you would like to attend you will need to let our secretary, Sue Duncan know please so we can track who is at the meeting and which group or local association they are representing. As part of the Association Meeting we have a talk from Charles Moffat our committee member. Charles is a former Senior Investigating Officer, Expert Witness and Advisor on Professional Standards and his talk is about "Corruption, Professional Standards and What to expect from a DVSA Investigation". Meanwhile he has been busy helping and supporting members. It's a first for us to be holding an AGM by zoom but we are getting used to the new skills needed and as a team we are constantly learning during Covid-19.

Graduated licences are shelved currently:

The Government has decided not to introduce graduated driver licensing (GDL) at least for the time being. The Transport Committee had been looking at and debating the issue along with taking expert advice over several months which had been hindered by Coronavirus. GDL is a scheme which places restrictions on new drivers for a period of time after passing their driving test for example not being able to drive at night or not driving with passengers under a certain age. However, giving evidence to the Transport Committee's young driver inquiry the roads minister Baroness Vere of Norbiton said the Government is not progressing work on GDL at present and instead, it will continue to focus its efforts on the Driver 2020 research project. The research which is costing some £2 million is designed to provide further evidence of what we need to do in this area. Driver 2020 is a research project which aims to help newly-qualified drivers improve their skills when they begin driving post-test. Described as the largest 'real-world' trial of its kind anywhere in the world, Driver2020 was launched by the Transport Research Laboratory (TRL) in 2019. Our understanding is that the focus will be on all-weather driving and night time driving education.

Consultations to reply to:

The following consultations may be ones you would like to take part in whilst you may have more time. The first is one on Parking on Pavements: This ends on November 22nd *click here.*

Another is the updating the mobile phone laws consultation

People using a hand-held mobile phone in all circumstances while driving will be breaking the law, under new government plans unveiled by Roads Minister Baroness Vere to close a legislation loophole brought about by the developing technology over the years. It's already a criminal offence to use a hand-held mobile phone to call or text while driving, but not for other actions such as taking photos. While still distracting such actions aren't seen as 'interactive communication 'so do not fit the current definition of the offence. Following a review of the offence, a consultation has been launched on bringing the law into line with modern technology meaning drivers caught taking photos, playing games or scrolling through a playlist behind the wheel will be clearly breaking the law. Ministers have rejected calls to go further by banning the use of hands-free functions. Drivers will still be able to continue safely using devices 'hands-free' while driving, such as a sat-nav secured in a cradle. The consultation closes on 17th January 2021and can be found *here*.

Finally:

Thank you all as members for staying on board the association and helping us by spreading and sharing the information about who we are and what we do. Also thank you to the wonderful team I work with on the committee, their hard work is inspiring.

During the first lockdown these were the words of Jacob Rees Mogg, Leader of the House of Commons:

"Driving instructors are one of the unseen engines of the country. They train future generations of drivers and I hope they can resume their important work safely as soon as possible". One of our aims must be to get the recognition that we all deserve for the important and vital work we all undertake. The difference with our lessons currently is that we are all adapting to holding them in a Covid secure way.

As I send this to our editor Parv Walling who does such a great job each month with this newsletter news is coming in of a vaccine that may be available as soon as the end of this year for the most vulnerable categories. News that we may be able to return to a "new normal" by the spring is something to be hopeful about and helps us all stay positive.



Excluded

We remain extremely concerned for our members who have been excluded from any financial help. These include the newly self-employed, people who worked hard to come into our industry but through sheer bad timing don't qualify for help. It also includes people who have served their country in the military and are in receipt of a pension and are now being penalised for their service.

There are nearly 3 million people in the UK in similar positions who have not received any financial help from the government since March.

On 5 November the **ADINJC** wrote again to the Chancellor and to the Business Secretary to ask for consideration to be given to people in this situation as it is clearly unacceptable.

We also wrote to MoneyBox and know that many of you have done so individually. Let's hope that the increased interest from the media will help push the government into some action. If you haven't done so already do consider writing in yourself, the more people that do the more likely they are to take some notice.



In case any of you use the theory test centre in Oban, it is currently not possible to use the usual location due to Covid 19 concerns. Cornish war veteran driving instructor 'has to stand in rain'

(Pre Lockdown 2)

A disabled war veteran driving instructor said he has been repeatedly forced to sit outside during wet and windy weather because of the closure of test centre waiting rooms. Andy Small, from Cornwall, said blanket national *closures due to Covid-19* were "ridiculous". "All instructors now have to sit or stand, outside, for up to 40 minutes while tests take place," he said. The Driver and Vehicle Standards Agency said it was reviewing the situation. Mr Small was medically discharged from the army in 2010 and has rheumatoid arthritis. He served in the Gulf War, completed two tours of Bosnia and was awarded the *Royal Warrant* in 2005. He said he could not stand for long periods so when pupils have been taking their tests, he would be sitting in the car park in a camping chair, holding an umbrella.

Lockdown 2 currently in action

New National Restrictions from 5 November

Information on the new national restrictions, including what they mean for working from home and business closures, why they are being introduced and the financial support available.

Remember - 'Hands. Face. Space':

- Hands wash your hands regularly and for 20 seconds
- Face wear a face covering in indoor settings where social distancing may be difficult, and where you will come into contact with people you do not normally meet
- Space stay 2 metres apart from people you do not live with where possible, or 1 metre with extra precautions in place (such as wearing face coverings or increasing ventilation indoors)

Applies to: England (see guidance for Wales, Scotland and Northern Ireland)

COVID-19 case numbers are rising rapidly across the whole of the UK and in other countries. We must act now to control the spread of the virus. The single most important action we can all take to fight coronavirus is to stay at home, to protect the NHS and save lives.

When we reduce our day-to-day contact with other people, we reduce the spread of the infection. That is why, from Thursday 5 November until Wednesday 2 December, you must:

- 1. Stay at home, except for specific purposes.
- 2. Avoid meeting people you do not live with, except for specific purposes.
- 3. Close certain businesses and venues.

These new measures will reduce the growth rate of the virus, which will:

- prevent the NHS from being overwhelmed
- ensure schools, colleges and universities can stay open
- ensure that as many people as possible can continue to work

On Thursday 5 November these national restrictions replaced the Local Covid Alert Level measures. The new measures will apply nationally for four weeks up to and including Wednesday 2 December. At the end of that period, we will return to a regional approach, based on the latest data.

These measures will be underpinned by *law*.

Police and other authorities will have powers to give fines and break up gatherings.

HANDS FACE SPACE

Bolton has lost one in seven driving instructors over the last eight years, figures show. Figures from the Department for Transport and the Driver and Vehicles Standard Agency (DVSA) show there were 290 Approved Driving Instructors in Bolton's BL postcode areas in June. This was 15% fewer than the 340 in June 2012, the earliest year figures are available. Across Great Britain, the number of instructors has fallen from 46,276 to 38,690 over this period – a drop of 16 per cent. We (NJC) were approached by James Mutch of the Bolton News and said the reasons for the number of instructors across Great Britain falling by more than 10% can be traced back to the last recession. 

Public Liability Driving Tuition

Why is Public Liability cover so important?

Because we all make mistakes in life, including in our business operations as a driving instructor. Quite simply, if a member of the public (or any other third party) is injured or suffers damage to their property, arising out of the conduct of your business as a driving instructor, you could be held responsible.

The ADINJC Public Liability insurance, is designed to provide protection from claims against you by third parties who may have suffered personal injury or damage to their property, during contact with your driving school. Most motor policies provide you with a compulsory £20 Million Public Liability cover for accidents and injuries that occur as a consequence of having an accident. The ADINJC believes it's important to ensure you also have sufficient cover away from the vehicle, and have therefore arranged for its paid up members to benefit from £10 Million Public Liability cover away from the vehicle. The policy also has a low policy excess of just £500 for each and every claim. The ADINJC policy provides £10 Million cover for each and every claim during the life of the policy.

A range of claims can arise. These can extend from accidents at your own business premises, to incidents that occur whilst providing advice or tuition whilst working away from your vehicle.

Increasingly, it is a requirement of many customers, principals, and clients (particularly local authorities and government agencies), that you be asked to present proof of Public Liability insurance before they will work with you, or allow you to work on their property or premises.

Compensation arising from Public Liability claims can be substantial, and may include loss of earnings, future loss of earnings and damages awarded to the claimant. In addition, considerable legal costs in defending the claim can be incurred, and the claimants' legal costs may also be awarded against you if you are found to be at fault. All would be covered under a comprehensive Public Liability policy

Claims for trips, slips and falls are the most common, but there are other events that can lead to a claim against you. The following are examples of potential claims that can give rise to public liability claims against your driving school:

- you open your door for a pupil who you inadvertently trip over, causing an injury;
- you spill a hot drink in a classroom and a pupil slips over on this, causing an injury;
- a pupil falls over some cones you have positioned to practice parking, causing an injury;
- you knock over a valuable antique whilst waiting for a pupil at their home;

All practical and theory tests suspended in England: update

We previously let you know that all practical driver, rider and theory tests would be suspended in England whilst the new national restrictions are in place. Following clarification from the Government these restrictions will last up to and including Wednesday 2 December 2020. This means all driver, rider and theory tests will restart on Thursday 3 December. We have emailed everyone with a test booked between Thursday 5 November and Wednesday 2 December to let them know it will be rescheduled to a new time and date. Driver and rider training should not restart until Thursday 3 December. We will continue to keep the situation under review in line with Government advice.

The Welsh Government has confirmed it will be lifting the firebreak restrictions in Wales from Monday 9 November.

What this means for you and your pupils

You can restart taking your pupils out on lessons from Monday 9 November.

What this means for practical tests

All practical tests will also restart on 9 November in Wales. This includes:

- car
- car and trailer
- motorcycle module 1 and 2
- vocational tests including Driver CPC module 4
- tractor tests
- ADI part 2 and 3
- ADI standard checks

Driving tests

Car windows must be open throughout the test

At least 2 windows on opposite sides of the car must be open throughout the test. Any combination of windows can be opened, for example, one from the front and back. Your pupils are advised to wear clothing suitable for the weather.

Make sure your car is clean

Because of coronavirus (COVID-19), you must clean the inside of your car before your test. This means:

- tidying any unnecessary items away from the dashboard, footwells, door pockets, cup holders and seats.
- wiping down the dashboard and car controls

The examiner will do an additional clean of some surfaces.

Wearing a face covering for practical tests

Your pupils must bring and wear a face covering for their practical test, unless they have a good reason not to. Good reasons are things like:

- having a physical or mental illness or impairment, or a disability
- wearing it would cause them severe distress

If they refuse to wear a face covering they will not be able to take their test.

If they do have a good reason they need to tell us when they book their test.

Reopening waiting rooms in Welsh test centres

As the UK government has announced further national restrictions in

England, we're pausing our plans to open up waiting rooms in England until after 2 December. We'll assess the feedback from instructors, customers and our examiners from the waiting rooms opened as part of the initial rollout to see how we can safely open up other waiting rooms in Wales. We'll update you again about waiting rooms as soon as possible.

What this means for theory tests in Wales

All categories of theory test will also restart in Wales on 9 November including ADI part 1 tests. Your pupils must bring and wear a face covering for their theory test, unless they have a good reason not to. Good reasons are things like:

- having a physical or mental illness or impairment, or a disability
- wearing it would cause them severe distress

They need to say if they have a good reason not to wear a face covering when they book their test. If your pupil cannot wear a face covering, they must tell us when they book their test. If they already have a theory test booked and have a good reason not to wear a face covering they need to call Pearson VUE on 0300 200 1122.

Update on driver CPC training

We wrote to you on 3 November 2020 to give you an update on how the national restrictions in England would affect DVSA services. We want to clarify how driver CPC training is affected by the restrictions. Where possible driver CPC training should be done remotely. But where this is not possible, classroom-based teaching in a suitable COVID-secure location environment is allowed. You should not carry out in-vehicle training. We will continue to keep this situation under review in line with government guidance.

Caught on camera – 10,000 tailgaters spotted in just two weeks

Almost 10,000 vehicles were caught tailgating in the first two weeks of new cameras being tested to clamp down on the offence.

A survey for Highways England found that while more than a quarter of drivers admitted to tailgating, nearly nine in 10 people say they have either been tailgated or seen it.

Highways England and police have joined forces to tackle the offence which is a factor in around one in eight casualties on England's motorways and major A roads.

Soon, motorists caught tailgating can expect to receive letters advising them they were too close to another vehicle and highlighting the dangers of not leaving safe braking distances. The clear message – stay safe, stay back! - comes as new footage shows the reality of tailgating. Roads Minister Baroness Vere said:

'When people think of the causes of road accidents, tailgating probably isn't one of them, but it's one that can have dangerous repercussions. Highways England's innovative plans are already showing how serious and reckless this behaviour is, and through this campaign I hope we see tailgating drop, making our roads, already some of the safest in the world, safer still'.

I will begin, this month, with a story from the Mail of October 30th with the intriguing headline 'Thin blue dine! Hungry PC's 80mph crash'. It said that after a tiring 12-hour shift, PC John Byrne was looking forward to his dinner. So when his wife sent him a picture of what she had made for him, the hungry officer didn't hang about. Unfortunately, he was in a bit too much of a hurry, turning on the blue lights on his patrol vehicle and accelerating to 80mph – double the speed limit for the builtup area through which he was travelling. He drove through a red light and then crashed his police car into another car in south Liverpool. Last month the 28-year-old officer – who served as a royal guardsman in the RAF before joining Merseyside Police – was banned from the roads. But it emerged that he is to keep his job, albeit with a final written warning. A police disciplinary hearing found he had breached professional standards but not to the extent that his actions merited his dismissal. At Manchester Crown Court, PC Byrne, of St Helens, admitted dangerous driving and was banned for 12 months and handed a 12-month community order. He must also carry out 40 hours of unpaid work, pay £355 prosecution costs and pass an extended driving test before he is allowed back on the roads. Well there we all are then, I wonder what you have to do to breach professional standards to the extent that your actions merit dismissal from Merseyside Police?

And there was another piece in the Mail of October 30th entitled 'Driver's ban for her meal on wheels'. It told how a disqualified driver with 26 points on her licence was caught driving with no hands while eating her dinner. Amy Richards, 50, drove through Guilford town centre holding her plate in one hand and eating with the other in October last year. Officers noticed the car was not taxed and followed it before Richards, from Cranleigh, Surrey, swerved to the other side of the road. She pleaded guilty to driving while disqualified, uninsured and not in proper control. She was given a further ban for two years and six points on her licence. As Pete Seeger sang: "When will they ever learn?"

There was a picture story in the Mirror of October 10th which showed an Audi Q5 lying on its side next to a mangled £150,000 McLaren supercar following the mother of all car park prangs. The Audi was believed to have mounted the bonnet and roof of the 570GT Coupe and flipped after its driver misjudged the angle while pulling into a neighbouring space. Emergency services had to free the Audi driver at Sainsbury's in Sevenoaks, Kent but no one was seriously hurt. Perhaps they should bring back the bay park in the driving test?

The saga of the smart motorway rumbles on. There were two letters in the Mail of October 26th which joined in the argument against them. The first was from a retired police officer who used to patrol the M1, which had been the scene of a fatal crash six days earlier. He said that "Smart motorways are the most dangerous and stupid idea ever devised by the Department for Transport. In the event of a breakdown or emergency, there is nowhere to go for safety. The official answer is that a driver should make their way to one of the lay-bys, but that is easier said than done because they are a mile apart. A hard shoulder is also vital for giving the emergency services access to the scene of an accident. What will happen if an electric car runs out of power in the dark on a motorway in wet weather? No lights or hazard warning lights and no way to move the vehicle. Why is the Government pressing on with this crazy scheme? Halting it would save millions of pounds and certainly many lives". The second letter was from an HGV driver with more than 40 years' experience.

"I believe smart motorways are an ill thought-out and tragic mistake by someone who probably drives a desk rather than a vehicle. The hard shoulder gives refuge to a broken-down vehicle, but on a smart motorway, at best a break-down will hold up the traffic and at worst cause a fatal accident. I have to agree with both letter writers.

And from one not-so-bright idea to another. The Mail on Sunday of November 8th carried a double page feature with the headline 'End the cycle lane madness'. It said that drivers across Britain are facing traffic chaos as councils block off miles of roads to hastily install cycle lanes – which are hardly being used. Many of the routes, most marked simply by bollards and cones, take up existing traffic lanes, narrowing busy trunk roads and causing severe congestion in towns and cities. They are being rushed out as part of a £2billion initiative to try to encourage more people to cycle to work rather than use public transport or their cars during the pandemic. But they have left drivers fuming as they queue next to the empty routes – with official Government figures showing the number using bicycles has actually fallen by 25 per cent since the first national lockdown was imposed in March. The new lanes are even holding up emergency vehicles. An ambulance crew in Sheffield on a blue light call had to remove bollards and cones to get past stationary traffic. There has also been a furious reaction from residents who have seen roads closed in their neighbourhoods to facilitate the schemes. As objections mount, and in a complete U-turn of the multi-million-pound project, many of the cycle routes are now being ripped up, at more cost to the taxpayer. Madness indeed.

And in the same issue of the Mail on Sunday there was a good piece by Nigel Farage with the headline 'Stop being so pious, pay road tax – and obey the rules like us motorists'. Mr Farage said: "Cycling used to be an innocent childhood pastime – a chance to see the world and enjoy a first taste of freedom. Many of us wish it had stayed that way. Today, cycling is an exploding craze, a macho, high-speed hobby bringing town-centre traffic to a stop and turning the roads near my home into a velodrome. It is creating frustration and anger in millions of people simply trying to go about their business. Country lanes are commandeered by self-righteous platoons of middle-aged men in tight-fitting costumes. In town, a journey to the Westminster office seems like a trip through the streets of Peking or Amsterdam. When I stop at traffic lights, cyclists surround me like a strange swarm of insects. Many completely ignore the rules of the road – that much is well established – yet cyclists are the new kings of the highway, accountable to nobody. Of course, the rest of us are told to shut up because cycling is the green alternative, better for the environment and healthy living. And so on.

A third piece in this issue of the Mail on Sunday revealed that the Government is rewriting the Highway Code to give cyclists more protection on the road. Car and lorry drivers will automatically face the blame for accidents with cyclists due to sweeping changes planned for the official guide. However motoring groups are worried about the 'hierarchy of users' guideline which says pedestrians and cyclists will have the right of way and those in cars, vans and lorries will bear greater responsibility to keep them safe. Critics believe it means drivers will face the blame even if a cyclist was really at fault – and that the amendments may push up motor insurance premiums. The proposed change states: "Those in charge of vehicles that can cause the greatest harm in the event of a collision bear the responsibility to care and reduce the danger posed to others. This principle applies most strongly to drivers of large goods and passenger carrying vehicles". Another change would grant cyclists the right of way to 'undertake' vehicles, even if the driver is already indicating to turn left (good grief!). The new code is set to say: "You [the vehicle driver] should stop and wait for a safe gap in the flow of cyclists if necessary." The Road Haulage Association, which represents 7,200 truck companies, has written to the Department for Transport raising concerns about the changes,

which are due to be published next year. Its letter says: "The 'hierarchy' lessens the responsibility of some road users and increases liability and responsibility of others. The proposal seems to make some road users partially responsible for the behaviour of other road users based solely on the size of vehicle or device used on the roads. This is inappropriate." However, Duncan Dollimore, head of campaigns at Cycling UK, said: "The Highway Code clarifies the position of all road users. The 'hierarchy' does not say people have no responsibility for their own safety, or of others. It simply indicates that if you have a vehicle that can cause more harm, you have greater responsibility." Well there we all are then.

The Sunday Mirror of October 25th carried a story which said that a car which may have been used for secret trysts by Edward VIII and Wallis Simpson could fetch up to £40,000 at auction. The future king and US divorcee Simpson are believed to have secretly travelled around London in a 1933 Humber Snipe. Now a collection of 15 are going under the hammer, including the one allegedly used by the pair. Alan Marshall, 64, from Hull and his father Reg, built the collection over 60 years. Alan said: "I was told it had been used by Edward and Mrs Simpson because it was perfect for privacy. Thanks to its small back window, you couldn't see who was inside." When George V died in 1936, Edward ascended the throne, but his plan to marry his lover caused a constitutional crisis and he abdicated that year. The auction, by Hansons, was due to take place on November 5th and if I find out the price the Humber realised, I will let you know.

And I will end this month with a story from The Sun of October 27th. It had the headline 'Starmer Harmer Drama'. An onlooker the day before described hearing "a loud bang" and then seeing a cyclist on the ground "in a lot of pain" after an accident involving Sir Keir Starmer. Police are probing the collision, which resulted in the rider being taken to hospital clutching an injured arm. Labour leader Sir Keir, 58, exchanged insurance details with the cyclist before leaving him in the care of paramedics. By the time two police cars arrived at the scene in Kentish Town, North West London, on Sunday lunchtime Sir Keir had left. Cops (Sun language) later left a message at his nearby home asking him to report to a police station. Sir Keir, a former Director of Public Prosecutions, said he attended a police station that day and is believed to have given a full statement about the crash. He is said to have been driving an SUV when it was in collision with the cyclist outside a pub. Bizarrely the Sun pictured Sir Keir outside Kentish Town Police Station yesterday morning but he later claimed he had been on a trip to "his tailors". I suppose if the suit fits.....

And finally,



DRIVING INSTRUCTOR INSURANCE EXPLAINED

Driving Instructor Insurance - features explained

Any Driver Cover - It is essential for your policy to be issued on an any driver basis; this allows you to teach any licensed driver on the road irrespective of previous driving experience or other risk factors. This also allows the examiner to drive if required, as you will not be able to provide his or her details to your insurer prior to your pupil taking their test.

Replacement Dual Control Vehicle Cover - As a business car insurance policy it is important to ensure you get the correct replacement vehicle suitable for your needs. Most standard car insurance products will only offer you a non-dual controlled car in the event of a non-fault incident meaning you're unable to continue working. Many specialist driving • Additional speedo instructor insurance providers will provide you with a dual controlled vehicle in the event of a claim. You should try to find a provider who will supply you with a guaranteed dual control replacement car within 24 hours to enable you continue teaching and sit any pre-booked driving tests. You should also consider how long you may need this vehicle for many providers will only supply a vehicle for a limited period try to find a provider who offers unlimited cover

Negligent Tuition Cover - This cover extends you're driving instructor insurance policy to insure you and any driving instructor engaged by you to whom you have provided a vehicle which is insured under your policy, for your/their legal liability to pupils whilst driving instruction is being provided.

Driving Off Road Driver Aged 14+ - Some driving instructor insurance policies provide extended cover to allow you to teach pupils off road who are aged 14 or over. This cover is only provided where it can be evidenced that the land you're using the vehicle on does not form part of policy and provide cover suitable for your needs.

Cover for Hire & Reward - As a driving instructor you will be collecting money for giving lessons whilst carrying your client in the vehicle this requires hire and reward to be included within your policy for the purpose of driving tuition and test. Standard private motor policies will not include this type of cover.

Modified Vehicle Cover - As a driving instructor you will have a number of additional features added to your vehicle these can include:

- Dual controls
- Additional speedo
- Additional mirrors
- Sign writing
- Disabled driving equipment

Most standard car insurance policies will class these as modifications and will therefore not be able to provide cover. It is important to mention these to your insurance provider so that they then can note these on your

Helping to make a difference

When navigating such uncertain times, it would probably be far easier to drop our heads in the sand and hope things improve quickly. However, Susan McDonald and Bobbie Hicks both ADIs have joined forces to try to help the many struggling ADIs/PDIs out there who've been excluded from financial support during the 1st and 2nd lockdowns. Their efforts to date are both inspirational and admirable and here are their stories:



Susan McDonald - My name is Susan McDonald and I am a self-employed Driving Instructor from Billingham in Teesside. Since my partner died in 2006, I have been a single parent to 3 amazing boys (actually, they are now men - but they're still my boys)! Prior to being an ADI, I spent my working life in various offices working in administration and financial roles until I was made redundant and my father died shortly after. At this point I realised that there was more to life than sitting in a boring office all day and that now was the time to make the change and do something I actually wanted to do and not something I had to do to make ends meet. Many, many years before I had wanted to become a Driving Instructor, so I decided that it was now or never.

In my 'spare' time, for over 30 years, I have been a volunteer of a Registered Charity which is the local branch of the National Charity Phab. During this time, I have held the positions of treasurer, administrator, Assistant Chairperson, fundraiser, leader, and organiser and I am currently the Person In Charge of the Charity and also the Manager of the Community Centre which we have the lease of. In my younger days I was also one of the founder members of the Phab Youth Council.

During the first lockdown I noticed a lot of ADI/PDI's were saying how much they were struggling to make ends meet as they were not entitled to any financial help and were unable to earn a living due to restrictions imposed. Some of these people were really struggling and seemed quite desperate. At this time, I thought that there must be some help somewhere for these people, but there was nothing for so many of them and I wished I could help them in some way.

In November, as we entered a second lockdown I noticed a lot of people again starting to worry about how they were going to survive yet another lockdown without help and started to think of a way I could help. I decided to ask a small Facebook group for their opinion on setting up a fund to help the 'forgotten ones' and found that many people were willing to donate. Bobbie Hicks got in touch with me and we discussed how this could be possible and if the fund could actually help people and we decided it was 'worth a try' so together we set up a GoFundMe page. Within the first few days the fund had raised almost £300.

The main aim of the fund is to ask fellow Driving Instructors, family and friends if they could donate any amount to be able to provide a little financial assistance to fellow ADI/PDI's who find themselves in financial difficulty through no fault of their own. There will be a strict selection process to ensure that the funds are allocated fairly and to the people who really need them.

Bobbie Hicks - 'I have been a driving instructor for about 27 years, during that time I have taken further training to become an Accident Investigator and then later a Fleet trainer. For a while during the second lockdown, I was thinking about setting up a Go Fund me page to help all the ADI's and PDI's whose stories I was coming across on Facebook. I saw Susan McDonald's post about a similar idea and contacted her and this project was started. It seems like a scary thing to do, but we cannot live in fear, so we took the bull by the preverbal horns and launched the Go Fund me page.'

The ADINJC will be supporting and working in association with members Susan McDonald and Bobbie Hicks who have taken the initiative to set up a Go Fund Me Page for struggling ADIs and PDIs. Our Governing Committee is in support of this worthy cause, and we hope our members will be too. Having spoken with them they have a well thought out and very positive plan and they should be applauded for what they are trying to achieve. We all agree that with the backing of the ADINJC and hopefully others in the industry we can have a fund for struggling ADIs not just through the trials and stress of COVID-19 but after that time too. The NJC is already thrilled by offers to help with this so we can secure a pot of money to get this underway as soon as possible. We hope that if as ADIs ourselves we can all make a small contribution we can help those struggling to cope. Having run our "Talk Line" during the pandemic we became acutely aware of ADIs who were desperate and alone. And we are only too well aware that there are many people who have fallen through the cracks of government financial assistance. As a starting point we are excited to announce that if we can raise £2,500 in the fund then Nick Moger, Chairman at Marmalade, and ADINJC sponsor, has generously offered to double that amount to £5,000.

We at NJC really look forward to helping Susan and Bobbie fulfil their vision and salute you both. Jolly well done ladies :-)))
